Dental Transformation Initiative

Domain 1: Increase Preventive Services Utilization for Children

- **Domain 1 Goal:** Increase statewide proportion of children ages 1-20 enrolled in Medi-Cal who receive a preventive dental service by 10 percentage points over a five-year period.
- The preventive dental service utilization rate for children ages 1-20 increased by 8.06 percentage points from CY 2014 to CY 2018.
- The number of Medi-Cal dentists providing preventive dental services to at least ten children ages 1-20 increased by 9.92 percentage points from CY 2014 to CY 2018.
- Payments as of September 2019: PY 1 - \$46.5 million, PY 2 - \$53.4 million, and PY 3 - \$53.1 million.
- September 2019: 241 SNCs are currently participating - increase of 6 since May 2019. SNC providers must complete and submit an Opt-In form available on the Domain 1 webpage and submit it to DTI@dhcs.ca.gov.
- Clinics - paper claims submission deadline is December 1, 2019 and electronic Data Interchange claims submissions deadline is December 20, 2019 for the January 2020 payment (PY 3 and 4).



Dental Transformation Initiative

Domain 2: Caries Risk Assessment and Disease Management

- **Domain 2 Goal:** Diagnose Early Childhood Caries (ECC) by utilizing Caries Risk Assessments (CRA) to treat it as a chronic disease.
- As noted in [PY 2 DTI Report](#), children ages 0-6 who fall into the three CRA categories within the 11 pilot counties, had a significantly higher increase of preventive dental services compared to the control group (children from the 11 pilot counties, ages 0-6 who had a restorative service in CY 2017 but did not receive a CRA).
- As of October 5, 2019, Domain 2 payments total \$36.3 million (\$28.6 million increase since May 2019). PY 1 (2017): \$2 million, PY 2 (2018): \$4 million, and PY 3 (2019): \$30.3 million.
- Prior to county expansion (Dec 2018), 212 providers opted in for 11 counties. Since the expansion to 29 counties, there are 2,833 providers opted-in as of October 15, 2019.



Dental Transformation Initiative

Domain 3: Increase Continuity of Care

- **Domain 3 Goal:** Increase continuity of care for beneficiaries ages 20 and under for 2, 3, 4, 5, and 6 year continuous periods.
- Payments as of July 2018:
 - PY 1 - \$9.8 million
 - PY 2 - \$12.1 million
 - PY 3 - \$13.2 million
- Domain 3 expanded from 17 to 36 counties and incentive payment increased from \$40 to \$60 per beneficiary with dates of service of January 1, 2019 or later.
- 100 SNCs are currently participating (26% increase since May). SNC opt-in deadline for PY 4 (2019) is October 31, 2019.
- Clinics: Paper claims submission deadline is May 1, 2020 and EDI submissions deadline is June 20, 2020 for the June 2020 payment (final payment for PY 3 and first payment for PY 4).



Dental Transformation Initiative

Domain 4: Local Dental Pilot Programs (LDPPs)

- 13 total executed LDPP contracts and the contract status for each is available in the [DTI DY 13 Annual Progress Report](#).
- CMS approved reallocation of \$14.4M funds from the First 5 Kern County and Northern Valley Sierra Consortium LDPPs. Nine LDPPs received additional funds to expand existing projects. LDPPs that focus on tribal communities are CSU LA, Humboldt, and CRIHB.
- As of October 2019, LDPPs received \$35.6 million:
 - PY1 (2017) - \$7.2 million
 - PY 2 (2018) - \$25 million
 - PY 3 (2019) - \$3.3 million

Proposition 56

Student Loan Repayment

- On July 11, 2019, DHCS announced its commitment to pay \$10.1 million in student loans via the Prop 56 Loan Repayment Program (CalHealthCares).
- In 2019, 38 dental awardees were chosen in 20 counties throughout California. Awardees were general dentists and specialty dental providers.
- Awardees have varied practice settings, including community clinics or Federally Qualified Health Centers, academic settings, group practice, and private practice.
- The recent announcement of awardees is the first of at least five rounds of funding.
