Evaluation and Data: Innovation Track

- Funded partners will also participate in an "appreciative inquiry" at the end of year 2.
- Appreciative inquiry is an approach to evaluation that focuses on strengths rather than on weaknesses.
- An external consultant will lead funded partners in a reflection to identify what is working well and what contributed to the success to identify innovative strategies, with illustrative examples of their success.

Evaluation and Data: Challenges and Successes

Challenges

- Collecting sub-population data (e.g., justice-involved, LGBTQ, foster youth, etc.).
- Collecting demographic data at one-time large events.
- Collecting sensitive data while building a relationship virtually.
- Time it takes for policy and system outcomes to occur.
- Insufficient data collected for outcomes.
- Reporting outputs rather than outcomes.

Successes

- Use of excel to allow for greater collaboration among the team.
- Additional data being collected to share outcomes.
- Building rapport with partners, and offering evaluation support through office hours and individual-check-ins.
