SUBJECT: Quarterly Invoice and Deliverables Deadline Bulletin (2022-005)

Per the Medi-Cal Health Navigators Project and Project Partner Allocation Agreement, project partners are required to submit various reporting documents throughout the duration of the project. These required documents are the Quarterly Invoice, the Quarterly Progress Report, and the Monthly Data Report. Below are the details regarding due dates and performance periods that project partners are expected to follow for each required document. Accurate and timely submission of required project documents is expected and project partners are expected to adhere to the deadline schedules below, and should plan accordingly. Invoice approval and/or payment may be delayed or denied for project partners who continuously submit late and/or have any number of outstanding deliverables. Any changes to the schedule below will be conveyed to the project partners via a subsequent bulletin.

Quarterly Invoice and Progress Report

As detailed in the Allocation Agreement, all payment requests must be submitted by the project partner to the State, on a quarterly basis, using a completed Navigators Project Quarterly Invoice, Attachment 3. Project partners can begin billing for project expenses once the allocation agreement has been executed and the quarter in which the allocation agreement was executed has ended. Per the California Prompt Payment Act, invoices will be processed and paid within 45 calendar days by DHCS' Accounting and the State Controller's Office. Along with the quarterly invoice, project partners are required to submit a Quarterly Progress Report, Attachment 5, by the due date and for the period listed below. Quarterly Progress reports will be required starting with the first quarter reporting period. Per the Allocation Agreement, project partners may be subject to partial or full loss of the approved Allocation Amount if they fail to produce satisfactory invoices, provide inadequate supporting documents, and/or fail to meet deliverable deadlines as outlined in this bulletin.
