Overview of Review Process

- » Utilizing feedback from various stakeholders involved in the ICF/DD Carve-In work, a stepwise approach was designed for the Inventory of Requirements and crosswalk.
 - 1. **Inventory:** Determine list of legislation, policy documents, manuals, etc. for review from known primary sources (e.g., DHCS, Department of Developmental Services [DDS], Regional Centers, MCPs, California Department of Public Health [CDPH], and Lanterman Act).
 - 2. Initial Review/Organization: Review documents and set up a spreadsheet to catalog and categorize requirements, pulling exact language from sources.
 - 3. Completeness Check: Solicit feedback on organized inventory from agencies/organizations for completeness and fill in any missing information with review of any necessary additional documents.
 - **4. Analysis:** Flag any duplication of requirements, gaps, or conflicting requirements and draft recommendations to address the duplication/gap/conflict.
 - **5. Decisions:** Make decisions based on review and discussion.
 - **6. Incorporation/Communication:** Determine best route of communication about decisions or changes (e.g., APL, ICF/DD Promising Practices/FAQ guidance document).

Crosswalk Category: Care Management

» Summary:

- » None of the documents reviewed for crosswalk contained any conflicting information about care management. However, additional clarity will be needed regarding care management role definitions for each entity serving the individuals.

- » Next steps:
 - » Include guidance in the APL and ICF/DD Promising Practices/FAQ guidance document.

Crosswalk Category: Information Exchange

» Summary:

- » None of the documents reviewed for crosswalk contained any conflicting information about information exchange. However, a process will need to be developed regarding how MCPs will be notified of member's address changes/changes in ICF/DD homes.

 - » Lanterman Act
 - » Regional Center MOU
- » Next steps:
 - » Include guidance in the APL and ICF/DD Promising Practices/FAQ guidance document.

Crosswalk Category: Outcomes and Quality

» Summary:

- » None of the documents reviewed for crosswalk contained any conflicting information about outcomes or quality.
- » Because the Lanterman Act predates MCP involvement, there are a couple of items that need to be clarified:
 - » How will conflicts be resolved among MCPs, Regional Centers, and ICF/DD homes (e.g., the MCP may deny a service that Regional Centers or the provider feels is needed).
 - » There also needs to be a notification process to MCPs for situations in which a Regional Center has terminated a provider contract.
- » Sources included in this category:

- » Next steps:
 - » Include guidance in the APL and ICF/DD Promising Practices/FAQ guidance document.

Crosswalk Category: Payments and Rates

» Summary:

- » Of the documents reviewed for crosswalk, there was no conflicting information about payments or rates. However, ongoing work is needed to clarify:
 - » The ICF/DD SPA and Lanterman Act expectations regarding the transportation benefit.
 - » Clarification may be included in the APL and ICF/DD Promising Practices/FAQ guidance document to ensure that there is no duplication of billing regarding the transportation benefit.
 - » Also, CA Senate Bill 184 (2022), includes some rate-specific information related to COVID-19 and the directed payment rates.
 - » This information can be provided to the MCPs as a reference (either in the APL and ICF/DD Promising Practices/FAQ guidance document or separately).

Crosswalk Category: Regulatory

» Summary:

» Of the documents reviewed for crosswalk, there was no written conflicting information about regulatory processes, except that DHCS and DDS will need to continue to collaborate to clarify the expectations of Title 22 regarding the initial and continued stay authorization timelines for ICF/DD services. Provider feedback has indicated that authorizations are currently provided for two years, following the approval of the Regional Centers.

Crosswalk Category: Member Rights

» Summary:

- Of the documents reviewed for crosswalk, there was no written conflicting information about members' rights. However, there are requirements within the Lanterman Act for how members and members' family members can get access to their health information. Because these data are separate from the MCP information, it is recommended that the processes for ICF/DD home provider and Regional Center information and MCP member information remain separate in their own processes.
- » In addition, there are several pieces of information related to rights restrictions, service availability within the ICF/DD service model, and exclusions that need to be clarified, potentially in the model ICF/DD home provider-MCP contract language, for clarity on role expectations.

 - » DHCS and DDS to draft language regarding the Member Rights requirements and share with the Stakeholder Workgroup for review and feedback, with the guidance included in the APL and ICF/DD Promising Practices/FAQ guidance document.

Crosswalk Category: Services

» Summary:

- » Of the documents reviewed for crosswalk, there was no written conflicting information about services.
- » There is opportunity within the APL and ICF/DD Promising Practices/FAQ guidance document to clarify coverage of services and limitations related to dental services and transportation services.

Crosswalk Category: Training

» Summary:

The trainings related to person-centered planning, addressing behavioral needs, and habilitative services specified in the Lanterman Act and Health Service Code provide an opportunity to strengthen the relationships among ICF/DD homes, Regional Centers, and MCPs. While MCPs are not listed as required attendees, having key MCP staff participate in required trainings could assist in building alignment of philosophies and expectations. In addition, it may also be helpful for those trainings to be offered to other MCP network providers who serve people living in ICF/DD homes and/or those who have an intellectual and developmental disability (I/DD).
