**PURPOSE**

The purpose of this bulletin is to identify the various budget and cost reporting requirements for Fiscal Year (FY) 2001-02 in relation to the Substance Abuse and Crime Prevention Act of 2000 (SACPA).

**DISCUSSION**

In order to capture all costs associated with SACPA services, all agencies that receive SACPA funding must identify their costs and unit of service information. The attached exhibit identifies how SACPA expenditures must be reported on the Department of Alcohol and Drug Program's (ADP) budget and cost report.

The budget diskettes will be issued to the County Alcohol and Drug Program Administrators within two or three weeks of ADP releasing the FY 2001-02 Budget Act Allocation. The budgets are due back within 60 days of ADP issuing the FY 2001-02 Budget Act Allocation. We will issue the cost report diskettes in July or August of 2002.

**REFERENCES**

As stated in Health and Safety Code, Sections 9535(b)(2) and (3), counties are required to submit budgets for planned expenditures and cost reports for actual expenditures.

## **HISTORY**
