 Administration**PURPOSE**

This bulletin transmits the Revised FY 2001-02 Budget Act Allocation 4.0, reflecting the increase of the Federal Fiscal Year (FFY) 2002 Substance Abuse Prevention and Treatment (SAPT) block grant award.

**DISCUSSION**

The enclosed funding information for alcohol and drug program services conveys statewide and county-specific information. The Department received an ongoing increase of \$11.9 million in the FFY 2001 SAPT Block grant award. From the FFY 2001 increase, \$2.4 million Prevention Set-Aside funds and the \$0.6 million HIV Set-Aside funds were previously budgeted for one-time expenditures. This funding is ongoing and, therefore, is available as part of the FFY 2002 funding and is allocated to counties for local services as described below. The FFY 2002 SAPT block grant award included an increase of \$15.4 million. Of this amount, \$9.3 million SAPT discretionary funds, \$3.1 million Prevention Set-Aside funds, and \$0.8 million HIV Set-Aside funds are allocated to counties for local services as follows:

- Increases in SAPT Discretionary funds are allocated using the standard allocation methodology of \$2,500 per million, with the balance per capita.
- Increases in Prevention Set-Aside funds are allocated proportionately to each county's SAPT Prevention Set-Aside.
- Increases in HIV Set-Aside funds are allocated based on indicators of need and weighted amounts.

The remaining funds are held at the Department for support and local assistance services. Counties must amend these funds into their State Fiscal Year 2001-02

Combined Negotiated Net Amount (NNA)- Drug Medi-Cal State-County Contracts or NNA State-County Contract. Contract amendments with revised budgets are due to the Department by Thursday, May 30, 2002. Contract amendments must be fully executed with your Board of Supervisors' approval and returned to the Department by September 30, 2002. These FFY 2002 funds are available for expenditure from October 1, 2001 through June 30, 2003.
