**PURPOSE**

This bulletin transmits the Fiscal Year (FY) 2002-03 Addendum to *ADP Allocation Methodology: Current and Historical Practices, March 1997*.

**DISCUSSION**

The addendum includes the allocation methodologies for funds allocated to counties via the Net Negotiated Amount (NNA) and Drug Medi-Cal (DMC) contracts in FY 2002-03, as well as a glossary of acronyms and terms.

This addendum includes additional information to provide a more thorough description of the allocation methodology. The additional information includes: population data used to compute the Standard Allocation Methodology (Exhibit 2); and data used to compute the Substance Abuse Treatment and Testing Accountability Act Allocation (Exhibit 3).

For easy reference, the addendum uses the same format, section numbers, and titles as the *ADP Allocation Methodology: Current and Historical Practices, March 1997*.
