SUBJECT: INTERNATIONAL CLASSIFICATION OF DISEASES, TENTH REVISION (ICD-10) INCLUDED CODE SETS AND SYSTEM EDIT FOR SHORT DOYLE MEDI-CAL II BILLING

SUPERSEDES: MHSUDS INFORMATION NOTICE 16-016

REFERENCE: DEPARTMENT OF HEALTH AND HUMAN SERVICES, CODE OF FEDERAL REGULATIONS, TITLE 45, SECTION 162.1002 (EFFECTIVE JANUARY 16, 2009)

The purpose of this Information Notice is to inform Drug Medi-Cal Trading Partners about a correction to the requirements that was stated on the superseding [Information Notice 16-016](#). On page 2 of the Information Notice 16-016, it states “Each claim (837P) must include one International Classification of Diseases, Tenth Revision (ICD-10) outpatient diagnosis code on the included list from the Substance Use Disorder (SUD) ICD-10 outpatient table as the primary diagnosis code.”

The correction to this statement is it is not necessary for the primary diagnosis to be on the included list from SUD ICD-10 outpatient table. The acceptable diagnosis may either be the primary diagnosis or another diagnosis at the claim level. The requirement remains the same in that at least one of the four diagnosis code pointers at the service line, data element SV107, points to a claim level diagnosis that is valid from SUD ICD-10 outpatient table.

Revision to the Substance Use Disorder ICD-10 Included List

The following ICD-10 codes were omitted from SUD ICD-10 diagnoses codes list that was attached to Information Notice 16-016:

- F19930 - Other psychoactive substance use, unspecified with withdrawal, uncomplicated; and
- F19939 - Other psychoactive substance use, unspecified with withdrawal, unspecified.
