Subject: Billing Procedures for Medical Ancillary Services

This notice replaces the letter to all Institutions for Mental Diseases (IMD) sent by the Department of Health Care Services (DHCS) on November 17, 2006. The purpose of this notice is to reiterate that Medi-Cal does not cover health care services, including medical ancillary services for individuals (21 through 64 years of age) residing as inpatients in IMDs.

Effective immediately, Medi-Cal (California's state Medicaid program) is not to be billed for any health care services, including medical ancillary services, such as laboratory, X-ray, or other medical services performed off-site for persons residing as inpatients in IMDs when they receive services in an acute care hospital for a medical condition. Health care providers who perform medical ancillary services must directly bill the county of responsibility as identified on the Medi-Cal Eligibility Data System (MEDS).

In accordance with the Code of Federal Regulations, Title 42, Sections 435.1010(b)(2), 441.13, and 435.1009, California Welfare and Institutions Code, Section 14053.3, and California Code of Regulations (CCR), Title 22, section 50273, and CCR, Title 9, sections 1840.210 and 1840.312, neither Federal Financial Participation (FFP) reimbursement nor Medi-Cal funds are allowed for health care services, including medical ancillary services provided to persons residing in IMDs. Counties are financially responsible for the medical ancillary services performed off-site for persons residing in IMDs when they receive services in an acute care hospital for a medical condition.

Please take the necessary steps to immediately comply with the foregoing information, including informing all off-site health care providers of this billing requirement.
