- SUBJECT: Employment of Nurse Practitioners (NPs) in Psychiatric Health Facilities (PHFs)
- PURPOSE: Provide guidance clarifying that NPs are permitted to work and perform employment duties in PHFs within the scope of their discipline and licensure.
- REFERENCE: California Code of Regulations (CCR), title 22, sections 77001-77155; Welfare and Institutions (W&I) Code section 4080; Health and Safety (H&S) Code section 1250.2.

BACKGROUND:

DHCS has the sole authority to monitor, review, license, and levy fines on PHFs.¹ DHCS applies the standards set forth in the California Code of Regulations to license

PHFs and conducts periodic inspections to ensure compliance.² PHFs are licensed to provide 24-hour inpatient care for people with mental health disorders or other persons described in Division 5 (commencing with Section 5000) or Division 6 (commencing with Section 6000) of the W&I Code. These services include the following basic services: psychiatry, clinical psychology, psychiatric nursing, social work, rehabilitation, drug administration, and appropriate food services.

POLICY:

Treatment services in a PHF are provided under a multidisciplinary model. The patient should benefit from, and the law requires, a treatment team composed of medical professionals whose individual areas of training and education meet the treatment goals of each patient.³ NPs are permitted to work in PHFs⁴ and render treatment services which they are legally authorized to perform under their scope of practice according to California state law.

A PHF shall ensure that psychiatric services are provided by licensed physicians with training and/or experience in psychiatry.⁵ PHFs must have personnel policies concerning qualifications, responsibilities, and conditions of employment for each classification of employee, including NPs.⁶
