The purpose of this Information Notice is to provide 2016 updates to the adjustment codes for denied claims reported on claim payment/advice transactions (835) from the Short Doyle Medi-Cal system. These changes are part of the Committee on Operating Rules for Information Exchange (CORE) Rule 360, which are federally mandated as part of the Affordable Care Act, and has an implementation date of August 23, 2016. Information Notice 15-041 provided background on the Claim Adjustment Reason Codes (CARC) and the Remittance Advice Remark Codes (RARC).

To implement the CORE Rule 360 requirements, the CARC/RARCs will be changed in accordance to the enclosures for Substance Use Disorder Services (Enclosure 1) and Specialty Mental Health Services (Enclosure 2) effective August 23, 2016. For certain claim denials, the description of the circumstance of claim denial is revised from the previously published descriptions to clarify the circumstance or to reflect the changes since the description was previously published.1
