**SUBJECT: SUMMARY OF 2007 CHAPTERED LEGISLATION AFFECTING,  
OR OF INTEREST TO MEDI-CAL MANAGED CARE PLANS**

This letter provides summary information on bills that were chaptered in 2007 and affect or may be of interest to Medi-Cal managed care plans that contract with the Department of Health Care Services (DHCS). We have enclosed the following:

- Summary table indicating the effective date for each bill, affected entities, and plan submissions and contract changes that will be required as a result of the legislation.

Assembly Bill 203 (Chapter 188, Statutes of 2007) was the health budget trailer bill for FY 2008-08. The budget trailer bill contained several provisions that directly affect the Medi-Cal managed care program as follows:

- Provides for the reimbursement to Medi-Cal managed care health plans to meet the special health needs of the members who transitioned from the Agnews Developmental Center to regional centers in Alameda, Santa Clara and/or San Mateo counties. (Section 23)
- Allows DHCS to initiate a pilot project in Sacramento and Los Angeles counties to provide Medi-Cal managed care enrollees a Personalized Provider Directory. (Section 52 and Section 57)

- Moves the authority for the negotiation of County Organization Health Systems contracts from the California Medical Assistance Commission to the DHCS. (Section 53)
- Provides direction for setting rates for Medi-Cal managed care health plans. (Section 90)

Please be advised that the chaptered legislation summarized does not reflect all changes in State law that may affect the business practices or daily operations of contracting managed care plans.

Each managed care plan is responsible for reviewing and analyzing the impact of chaptered legislation on its operations. Contracted managed care plans must implement statutory changes as required by the effective date of each chaptered bill and should not delay any required operational changes while the Medi-Cal Managed Care Division (MMCD) processes related contract amendments. In addition, managed care plans are responsible for compliance with any regulatory requirements that are enforced by other state or federal entities. Please see "General Terms and Conditions" of your contract.

The DHCS reminds managed care plans that, due to these legislative actions, it may amend your contracts to require the following changes: new or revised reports and data submissions, policies and procedures, provider directories, member informing materials, or subcontracts. Your contract may require DHCS review and approval of these changes. Please refer to your specific contract for approval requirements and time frames.

When necessary, MMCD will issue policy letters to clarify the application of some new laws to the Medi-Cal Managed Care program. Laws that contain provisions specific to Medi-Cal may require DHCS to promulgate new regulations as part of the implementation process.
