d) Description of what activities the requested funds will be used for

The following activities will be undertaken in the North Central Regional Partnership:

- Seeking and identifying workforce resources, such as federal, grant and foundation funding, and non-monetary and match funding opportunities with local labor, education and vocational rehabilitation entities
- Planning Mental Health Career Pathway Programs that serve multiple Counties in existing educational settings, such as high schools, adult education, regional occupational programs, community colleges and universities, in order to outreach to unserved and underserved communities and increase the diversity of the workforce
- Planning for a regional expert pool of clients and family members as speakers, trainers and evaluators in public mental health

e) Objectives to be achieved:

- Establishment of a regular meeting schedule with ongoing participation from public mental health, education, labor and employment service organizations
- Establishment of a regional partnership strategic plan for workforce education and training, to include mission, goals and objectives
- Developing a plan for sources of funding outside of MHSA Workforce Education and Training funding for participants in the regional partnership
- Developing a plan for a Mental Health Career Pathway Program in an unserved/underserved community
- Developing a plan for a client and family member expert pool for the region

<u>Operating Costs:</u> To include equipment, supplies, communication, travel, training, rent, utilities, insurance	=	30,000
<u>Administrative Overhead:</u> Staff and operating expenses @17.6%	=	<u>30,000</u>
