PURPOSE

The Department of Health Care Services (DHCS) is the agency responsible for the adjudication of Drug Medi-Cal (DMC) claims through the Short-Doyle Medi-Cal system (SD/MC). The SD/MC system is being replaced with the new Health Insurance Portability and Accountability Act (HIPAA)-compliant system, which is under development and known as SD/MC Phase II. Consequently, the Department of Alcohol and Drug Programs (ADP) DMC program and processes, as well as ADP's DMC trading partners, will be impacted.

The purpose of this Bulletin is to inform trading partners of changes to ADP's DMC billing process resulting from ADP's transition to SD/MC Phase II.

This Bulletin is the release of the SD/MC Phase II 837P/835, 276/277, and 997 Companion Guides. These Companion Guides describe in detail the requirements of the transactions for SD/MC Phase II.

This Bulletin and attached information is being released in anticipation of SD/MC Phase II; implementation date to be announced soon. The Companion Guide information will allow ADP's DMC trading partners to begin impact assessments and other necessary preparation for the implementation of SD/MC Phase II. A testing environment will be available for trading partners to test transactions in the SD/MC Phase II system prior to the implementation date.



DISCUSSION

All DMC counties and direct providers must submit their claims in the HIPAA format in order to be reimbursed. The details of the SD/MC Phase II requirements are described through the various exhibits attached to this Bulletin. Please read them thoroughly.

In order to administer and monitor the DMC program, the ADP relies on the current SD/MC system and HIPAA Translator to adjudicate claims and to generate specific claim-related information.
