SUBJECT: MAINTENANCE OF EFFORT REQUIREMENTS

This Information Notice provides detail on the changes in the amounts required to be deposited by counties and cities into their local health and welfare trust fund mental health accounts to meet minimum realignment maintenance of effort (MOE) requirements for Fiscal Year (FY) 1996-97 and thereafter. Chapter 64, Statutes of 1993 (SB 627) added Section 17608.05(b) to the Welfare and Institutions (W&I) Code to allow a county or city to limit its deposit of realignment MOE funds to the amount necessary to meet minimum federal MOE requirements. Chapter 6, Statutes of 1996 (SB 681), effective January 1, 1997, amended Section 17608.05(b) of the W&I Code to allow counties permanent MOE relief for mental health services up to \$25 million statewide per fiscal year.

This amended section requires the Department of Mental Health (DMH) to allocate the authorized \$25 million reduction of local mental health matching funds. To comply with this provision, DMH has established each county's maximum potential MOE reduction on a prorata basis as a percentage share of the FY 1990-91 statewide total match obligation (excluding county overmatch) pursuant to W&I Code Section 17608.05(a). Enclosed is a chart that indicates the realignment MOE reduction for each county and city for FY 1996-97 (Enclosure A).

The match relief provided by SB 681 takes effect on January 1, 1997. To assist counties in the computation of the monthly MOE deposit amounts, see Enclosure B.

COMPUTATION OF MONTHLY MOE FUNDS

I. Pre SB 681 MOE for 96-97 = \$12,000

Monthly Deposit = \$ 1,000

Deposits made July 1996
through Dec. 1996 = \$ 6,000

II. Post SB 681 MOE for 96-97 = \$ 9,000

COMPUTATION:

\$9,000	Reduced 96-97 MOE
- <u>\$6,000</u>	6 Months Deposit (July through Dec.)
\$3,000	Balance due for Jan. 1997 through June 1997

$\$3,000/6 = \500 Monthly deposit
