The Department of Health Services (DHS) has established the reimbursement rates for Long Term Care providers, which also reflects an increase, for fiscal year 1999/2000. Please be advised that DHS has informed the Department of Mental Health that the January 1, 2000 rate includes funding to increase the nursing staff requirements to 3.2 full-time equivalents. The per diem rate for Nursing Facilities Level B are as follows:

The Special Treatment Program (STP) patch will remain at \$5.72 per client/per day, but please note that the facility rates listed **do not include** the STP patch. The new Leave of Absence Bed Hold rate is \$4.62.

Pursuant to Section 5902(e) of the Welfare and Institutions Code, as long as Institutions for Mental Disease facilities have county contracts and retain Nursing Facility - Level B (formerly SNF) licensure and certification, they shall be reimbursed for basic services at the rate established by DHS, in addition to the rate established for STPs.
