SUBJECT: Regional Average Rates For Non-Contract Psychiatric Inpatient Hospitals For Fiscal Year (FY) 2022-23

PURPOSE: This notice provides annual rate information for Psychiatric Inpatient Hospitals which do not have negotiated rates with a Mental Health Plan.

REFERENCE: California Code of Regulations Title 9, Section 1820.115

BACKGROUND:

The Department of Health Care Services is responsible for annually updating regional rates for Fee-for-Service/Medi-Cal hospitals which do not have an existing contract with a Mental Health Plan. This Information Notice provides the methodology for determining the rates and an enclosure with the FY 2022-23 regional rates.

POLICY:

Per California Code of Regulations Title 9, Section 1820.115, the Department of Health Care Services shall determine the reimbursement rates for acute psychiatric inpatient hospital services for each Fee-for-Service/Medi-Cal hospital which does not have an existing contract with any Mental Health Plan.

The per diem rate by accommodation code shall equal the weighted average rate negotiated for all Fee-for-Service/Medi-Cal hospitals within the five Rate Regions. If there are no hospitals with negotiated rates within the Rate Region, the weighted average negotiated rate for all Fee-for-Service/Medi-Cal hospitals statewide are used.

The per diem rates include routine and all hospital-based ancillary services, but exclude professional services. Enclosed is the table displaying the regional average noncontract rates for FY 2022-23.
