WITHDRAWAL OF ALTERNATIVE BENEFIT PLAN STATE PLAN AMENDMENT (SPA) 19-0016: NEW SCHOOL-BASED VISION CARE SERVICE IN THE LOCAL EDUCATIONAL AGENCY MEDI-CAL BILLING OPTION PROGRAM (LEA BOP)

Dear Mr. Scott:

The Department of Health Care Services (DHCS) wishes to withdraw ABP SPA 19-0016, which was submitted on March 29, 2019. SPA 19-0016 proposed to align the ABP with SPA 19-0009 to provide comprehensive vision services and eyeglasses as a new service to the LEA BOP. DHCS submitted a withdrawal letter for SPA 19-0009 to the Centers for Medicare & Medicaid Services (CMS) on April 22, 2022. Consequently, DHCS no longer needs to update the ABP to align with SPA 19-0009.
