TREATMENT PROGRAM, EFFECTIVE JULY 1, 2020

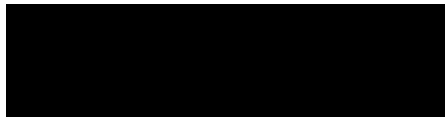
Dear Mr. Scott:

Pursuant to the Centers for Medicare and Medicaid Services' (CMS) direction, the Department of Health Care Services (DHCS) is formally withdrawing State Plan Amendment (SPA) 20-0006.

On September 30, 2020, DHCS submitted SPA 20-0006. DHCS subsequently split SPA 20-0006 into two separate SPAs (SPA 20-0006-A and SPA 20-0006-B) at CMS' request. On December 20, 2021, CMS formally approved SPAs 20-0006-A and 20-0006-B. Therefore, DHCS is formally withdrawing SPA 20-0006.
