STATE PLAN AMENDMENT 21-0033: CONTINUANCE OF PROPOSITION 56  
SUPPLEMENTAL PAYMENTS FOR THE FAMILY PLANNING, ACCESS, CARE AND  
TREATMENT PROGRAM

Dear Mr. Scott:

The Department of Health Care Services (DHCS) is submitting State Plan Amendment (SPA) 21-0033 for your review and approval. This SPA proposes to continue to provide supplemental payments under the Family Planning, Access, Care and Treatment (Family PACT) program for Evaluation and Management (E&M) office visits rendered for the purpose of comprehensive family planning services. DHCS seeks an effective date of January 1, 2022 for this SPA.

On November 8, 2016, California voters approved the California Healthcare, Research and Prevention Tobacco Tax Act (commonly known as Proposition 56 or “Prop. 56”) to increase the excise tax rate on cigarettes and tobacco products. The Budget Act of 2017, Assembly Bill 120 (Statutes of 2017, Chapter 22, Section 3, Item 4260-101-3305), appropriated Prop. 56 funds for specified DHCS health care expenditures during State Fiscal Year (SFY) 2017-18. The Centers for Medicare & Medicaid Services (CMS) approved SPA 17-029, which authorized supplemental payments from July 1, 2017 through June 30, 2018. Pursuant to the Budget Act of 2018, Senate Bill 856 (Committee on Budget and Fiscal Review, Chapter 30, Statutes of 2018, Section 3, Item 4260-101-3305), DHCS was authorized to extend the supplemental payments from July 1, 2018 through June 30, 2019, under approved SPA 18-0031. Pursuant to the Budget Act of 2019, Assembly Bill 74 (Statutes of 2019, Section 3, Item 4260-101-3305), DHCS extended the supplemental payments from July 1, 2019 through December 31, 2021, under approved SPA 19-0040.

The Budget Act of 2021, AB 128 (Statutes of 2021, Chapter 21, Item 4260-101-3305) extends the appropriation of Prop. 56 funds beginning January 1, 2022.

DHCS has been providing supplemental payments to Family PACT providers since July 1, 2017 with the approval of SPA 17-029. DHCS was authorized to extend the supplemental payments under approved SPA 18-0031 and SPA 19-0040. SPA 21-0033 would continue the supplemental payments, at a rate equal to 150 percent of the current Family PACT rates, to providers under Family PACT beginning January 1, 2022. The supplemental payments will be given to Family PACT providers for E&M office visits rendered for the purpose of comprehensive family planning services.


For SFY 2021-22, Prop. 56 supplemental payments for codes specified and amounts will continue without interruption, and changes are noted where applicable. The supplemental payments will be issued for the specified codes for dates of service beginning January 1, 2022, and will be made based on claim submission for the specific applicable procedures within the aforementioned categories.

DHCS posted a public notice on August 11, 2021, and 2 comments were received. In addition, DHCS received CMS approval to forego tribal notice on August 18, 2021.

**Continue the Proposition 56 Supplemental Payments for Family Planning, Access,  
Care and Treatment Program Services**

The Family Planning, Access, Care and Treatment (Family PACT) Program will continue to provide supplemental payments to Family PACT providers for Evaluation and Management (E&M) office visits rendered for comprehensive family planning services beginning January 1, 2022. These supplemental payments are equal to 150 percent of the payment amount determined based on the methodology described in Attachment 4.19-B, page 3g, last paragraph of the state plan for CPT procedure codes 99202, 99203, 99204, 99211, 99212, 99213, and 99214.

Prop. 56 supplemental payments beginning in January 1, 2022 will be made available for adjudicated claims once any necessary system edits to accommodate such payments have been implemented. Where applicable, subject claims received and paid prior to implementation of January 1, 2022 system edits will be paid in accordance with State Fiscal Year 2019-20 policy, and, upon implementation, will be retroactively reprocessed to accommodate any January 1, 2022 changes.

These supplemental payments do not change the underlying payment amount for the E&M procedure codes noted in Attachment 4.19-B, Page 3g of the state plan.
