PROPOSED STATE PLAN AMENDMENT TO CLARIFY THE HEALTHCARE PROCEDURE CODING SYSTEM QUARTERLY UPDATE PROCESS AND TO AMEND THE REIMBURSEMENT METHODOLOGY FOR NON-INSTITUTIONAL SERVICES

This notice provides information of public interest about a proposed State Plan Amendment (SPA) 22-0013 that the Department of Health Care Services (DHCS) plans to submit to the Centers for Medicare and Medicaid Services (CMS). The proposed SPA seeks to clarify the Healthcare Common Procedure Coding System (HCPCS) quarterly update process, whereby discontinued HCPCS codes are replaced by new HCPCS codes or new HCPCS codes established, and to amend the reimbursement methodology for non-institutional services, effective January 1, 2022.

Beginning January 1, 2022 and on the first of each calendar year quarter thereafter, DHCS will engage in a quarterly update process to establish new HCPCS codes, and reimbursement rates when necessary, for non-institutional services. DHCS will establish the reimbursement rates for new HCPCS codes based on the reimbursement methodologies for non-institutional services included in Attachment 4.19-B. SPA 22-0013 will also amend the reimbursement methodology for non-institutional services to include 80% of the lowest maximum allowance established by the Medicare program for the same or similar item or service as an additional factor that may be used when establishing reimbursement rates.

The annual aggregate Medi-Cal fee-for-service expenditure is indeterminate at this time. The impact on Medi-Cal reimbursement rates is unknown because the changes to the HCPCS codes have not been established in the Medicare system yet.

The effective date of the proposed SPA is January 1, 2022. All proposed SPAs are subject to approval by CMS.
