This action by the Department of Health Care Services (Department) eliminate the requirement that Mental Health Rehabilitation Centers (MHRCs), that also provide Adult Residential Treatment Services, obtain and maintain Social Rehabilitation Program (SRP) certification in addition to their MHRC licenses, because SRP certification is duplicative of MHRC licensing requirements and, therefore, unnecessarily burdensome on MHRCs to obtain and maintain and on the Department to regulate.

OAL approves this regulatory action pursuant to sections 11349.3 of the Government Code. This regulatory action becomes effective on 1/1/2021.

Amend Section 1840.332 to read:

- § 1840.332. Adult Residential Treatment Services [begin strikeout] Contact and Site [end strikeout] [begin underline] Provider [end underline] Requirements.
- (a) [begin underline]Programs that provide [end underline]Adult Residential

 Treatment Services shall have a clearly established certified [begin underline]or

 licensed [end underline]site for services, although all services need not be delivered at that site. Services shall not be claimable unless there is face-to-face contact between the beneficiary and a treatment staff person of the facility on the day of service and the beneficiary has been admitted to the program.
- (b) Programs that provide Adult Residential Treatment Services[begin underline], except Mental Health Rehabilitation Centers as defined in Section 782.34, Chapter 3.5, Division 1, of Title 9,[end underline] [begin strikeout]must-[end strikeout][begin underline]shall[end underline] be certified as a Social Rehabilitation Program by the Department as either a Transitional Residential Treatment Program or a Long Term Residential Treatment Program in accordance with Chapter 3, Division 1, of Title 9.[begin strikeout]Facility capacity must be limited to a maximum of 16 beds.[end strikeout]
- (c) [begin strikeout]In addition to Social Rehabilitation Program certification, p[end strikeout][begin underline]P[end underline]rograms [begin strikeout]which-[end strikeout][begin underline]that[end underline] provide Adult Residential Treatment Services [begin strikeout]must-[end strikeout][begin underline]shall[end underline] be licensed as a Social Rehabilitation Facility or Community Care Facility by the State
