Select from treatment types listed	This may include, but is not limited to, case management, medication management, outreach support, housing support, life skills support, substance use disorder treatment, and rehabilitation, individual/group counseling, etc.
Other Indicators of Successful Engagement	5348(d)(6)	29, 30	Additional measures, not included in the required elements (WIC 5348(d)), that demonstrates program efficacy and/or reduces homelessness, hospitalization, and involvement with local law enforcement by persons in the program.	Select from indicators listed; Number of individuals for each indicator	This may include, but is not limited to, participation in treatment, voluntarily accepting services when re-petitioned, probation/parole compliance, completion of court mandated treatment, substance use treatment completion, etc.
Satisfaction with services	5348(d)(14)	31, 32	The measure of satisfaction of AOT program and the services provided to individuals and/or family members of individuals served.	Number of individuals for each indicator	This may include, but is not limited to, testimony, program satisfaction survey/assessment, etc.

Adherence to Prescribed Treatment	5348(d)(5)	45	An individual that correctly follows a formal authorized treatment plan.	Number of individuals	Most commonly, this refers to medication or drug compliance, but can also apply to medical device use, self-care, self-directed exercises, or therapy sessions.
Enforcement Mechanisms	5348(d)(11)	46	A method(s) and/or action(s) implemented to ensure compliance of treatment by AOT individuals.	Number of individuals for each mechanism listed	This may include, but is not limited to, increased court hearings, case management, increased intensity and/or frequency of treatment, additional mental health evaluation, and/or medication outreach.
Substance Abuse	5348(d)(9)	48	A higher degree of misuse, whereby an individual continues to use alcohol or drugs despite the presence of negative impacts.	Number of individuals prior to enrollment and during enrollment	N/A
Maintain Contact with Treatment System	5348(d)(1)	50	An individual that consistently engages with the treatment system for the duration of receiving AOT services.	Number of individuals that fall in Likert Scale categories	N/A

Frequency of Treatment	5348(d)(10)	51	The average number of occurrences, periodic or recurrent, of treatment services provided to AOT program recipients in a week (7 days) span. This includes all face to face and non-face to face services provided to AOT individuals for the duration of enrollment.	The average number of occurrences in a week (7 days) span	N/A
Intensity of Treatment	5348(d)(10)	52	The average length of each encounter with an AOT individual. This includes all face to face and non-face to face services provided to an AOT individual for the duration of enrollment.	The average length (hours) of each encounter	This includes but is not limited to all hours billed.
Employment Services	5348(d)(3)	54	An individual that participates in vocational rehabilitation programs that offer job training.	Number of individuals	This may include, but is not limited to, internships, non-paid (volunteer) work experience, and/or job training activities, such as resume writing/interview skills, classes etc.

Employment	5348(d)(3)	55	An individual that is legally employed.	Number of individuals (before, during, and after enrollment)	This may include, but is not limited to, competitive employment, transitional employment, paid in-house work (shelter workshop/work experience, agency-owned business), other gainful/employment activity.
Social Functioning	5348(d)(12)	59-61	An individual's interactions and ability to self-manage, without impact from symptoms of diagnoses, within environments including, but not limited to, community, treatment program, social activities, and relationships with support systems.	Number of clients that demonstrated varying abilities at time of intake, at the end of initial period, and at time of discharge.	Examples of managing symptoms include not responding to auditory hallucinations, not posing harm to self or others, and distress tolerance and use of positive coping strategies. Environments may include but are not limited to, recovery support groups, extracurricular activities, jobs, religious groups, activity to help reduce antisocial behaviors etc.
Independent Living Skills	5348(d)(13)	64-66	An individual's ability to do activities relevant to daily living.	Number of clients that demonstrated varying abilities at time of intake, at the end of initial period, and at time of discharge.	This may include, but is not limited to, money management, cooking/prepare meals, housekeeping, self-administration of medication(s), finding transportation, and/or basic hygiene, etc.

Law Enforcement Contact	5348(d)(2)	69, 70	Any interaction with law enforcement that leads to the arrest, citation, and/or booking of the individual.	Number of individuals (before and during enrollment); number of days reduced of incarceration or jail	This may include, but is not limited to, probation/parole non-compliance, jailed/incarceration, etc.
Victimization	5348(d)(7)	71	The act or process of someone being injured or damaged by another person(s) resulting in physical or psychological harm to the victim.	Number of individuals (before and during enrollment)	This may include, but is not limited to, physical, verbal, and/or sexual aggression, threats, and/or hostility towards the individual.
Violent Behavior	5348(d)(8)	72	Any display of aggressive, reckless, and dangerous behaviors that have significant potential to result in physical and/or psychological harm.	Number of individuals (before and during enrollment)	This may include, but is not limited to, physical, verbal, and/or sexual aggression, threats, and/or hostility towards self and/or others.
Hospitalizations	5348(d)(4)	75, 76	An individual admitted to a health facility.	Number of individuals (before and during enrollment); number of days reduced	This may include, but is not limited to, psychiatric, emergency room, inpatient facility, and/or hospitals, etc.

Maintained Housing	5348(d)(1)	78	Individual did not experience one day (24 hours) homeless (as defined above) for the duration of receiving services through AOT program.	Number of individuals	N/A
Homelessness	5348(d)	79	An individual who lacks a fixed, regular, and adequate nighttime residence.	Number of individuals (before and during enrollment)	An individual with a primary nighttime residence that is a public or private place not designed for, or ordinarily used as, a regular sleeping accommodation for human beings, including a car, park, abandoned building, bus or train station, airport, or camping ground, or living in a supervised publicly or privately operated shelter designated to provide temporary living arrangements (including congregate shelters, transitional housing, and hotels and motels paid for by charitable organizations or by federal, state, or local government programs for low-income individuals), or who is exiting an institution where he or she resided for 90 days or less, and who resided in an emergency shelter or place not meant for human habitation immediately before entering that institution.
