To All Local Educational Agency Medi-Cal Billing Option Program (LEA BOP) Providers:

You are invited to attend the LEA BOP Advisory Workgroup (AWG) Meeting on January 25, 2023.

The LEA BOP Advisory Workgroup (AWG) meeting provides an opportunity for participating LEA BOP Providers and stakeholders to learn about program updates and participate in focused trainings on specific topics. The emphasis of the AWG meeting is to strategize various goals and activities aimed at expanding Medi-Cal services on school sites, increasing students' access to care, and facilitating appropriate federal reimbursement for providing services to students enrolled in Medi-Cal. The LEA BOP has made changes to the frequency of the AWG meetings in order to best facilitate the meeting.

1. The Department of Health Care Services (DHCS) will conduct quarterly AWG meetings via webinar on the last Wednesday of the first month of each quarter of the state fiscal year. This timing avoids most holidays and scheduled school closures.

 - Afternoon session is scheduled from 1:00 - 3:00 p.m. The afternoon session will consist of Cost and Reimbursement Comparison Schedule (CRCS) training for state fiscal year 2021-22.
