To All Local Educational Agencies Medi-Cal Billing Option Program (LEA BOP) Providers:

The purpose of this e-blast is to remind LEA BOP Providers that Educationally Related Mental Health Services (ERMHS)/Educationally Related Intensive Counseling Services (ERICs) are not covered services and are not eligible for billing under the LEA BOP.

The LEA BOP is a federally funded reimbursement program for the provision of certain medically necessary direct health care services to Medi-Cal eligible students. In contrast, ERMHS/ERICs do not require medical necessity because, by definition, they are educationally focused. Additionally, ERMHS/ERICs have a different funding source that is separate from the Medi-Cal reimbursement that LEAs receive through the LEA BOP. The California Department of Education (CDE) distributes ERMHS/ERICs funding directly to Special Education Local Plan Areas (SELPA), and in some cases, redistributed to LEAs for the provision of these educationally related services. Although some of the services resulting from an ERMHS assessment are services also covered by LEA BOP, such as individual or group counseling services, LEAs may not bill these services to the LEA BOP because of the potential for duplicate payment across funding streams. Psychology and counseling services are reimbursable under the LEA BOP only if these services are medically necessary, included on a care plan and did not result from an ERMHS/ERICs assessment.

LEAs may not bill ERMHS, including psychology/counseling services provided under ERMHS, to the LEA BOP. In addition, LEA Time Survey Participant (TSP) lists for Cost Pool 1 must not include practitioners designated as ERMHS/ERICs staff. Please make sure these participants are not present on the TSP list.
