# **Agenda Item I: Introductions**

## Agenda Item II: Quarterly Denied Medi-Cal Days

**Discussion:** The Fall Denied Medi-Cal Days data for dates of admission October 1, 2020 – December 31, 2020 is due on or before March 31. We will send out a reminder in the next two weeks or so to everyone if your facility has not already submitted the data.

#### Agenda Item III: COVID Admin Days Data

**Discussion:** At the request of the California Association of Public Hospitals (CAPH), DHCS has tabulated the number of COVID-19 Admin Days claims

resulting from the newly implemented COVID-19 Admin Days process. This process retroed back to March 18, 2020 allowing flexibility for hospitals to claim COVID-19 services as Admin Days. DHCS ran data for all hospitals and found approximately 420 Admin Days with the COVID-19 diagnosis in either the primary or secondary field. Of those 420 days, approximately 250 were specific to DPH. DPH are at the 60% ratio of those days being paid. DHCS expects this number to increase as the DPH continues to bill and review self-denied Admin Days.
