




Question 1: Do we need to exclude costs funded with COVID State funding?

- » The State Legislature appropriated COVID funding to schools through Assembly Bills 86 and 130
- » In-Person Instruction (IPI) Grant and Expanded Learning Opportunities (ELO) Grant funding received by LEAs does <u>not</u> need to be identified and removed on the CRCS in the "Federal Resources or Grants" column
- State resources used to fund direct health service expenditures that are reported on the CRCS are eligible for federal matching funds when those State funds are not a pass-through of federal funds

Question 2: Do we need to complete the CRCS if we did not conduct interim billing in SFY 21-22?




<u>Question 2</u>: Do we need to complete the CRCS if we did not conduct interim billing in SFY 21-22?

- » Yes, all participating LEA BOP providers must certify expenditures to meet the State's cost settlement requirement
- » LEAs that did not receive any interim payments for SFY 21-22 are required to complete the Certification of Zero Reimbursement Form (DHCS Form 6299a)
 - » LEAs completing the Zero Reimbursement Form are not required to submit the CRCS Form 6299.
- » LEAs can request a copy of the Certification of Zero Reimbursement Form from the LEA Inbox at <u>LEA.CRCS.Submission@dhcs.ca.gov</u>


Form 6299a Submission Requirements

- » LEAs should submit the Certification of Zero Reimbursement Form to: <u>LEA.CRCS.Submission@dhcs.ca.gov</u>
- » Utilize the following naming convention:
 - » State Fiscal Year.NPI_Number.LEA_Name.Submission Date.ZEROCRCS
 - » <u>Example</u>: SFY2022.9726458910.CaliforniaSchoolDistrict.3.1.23.ZEROCRCS.PDF
- » Forms must be submitted by March 1, 2023

Question 3: I have contractor invoices that show the hours worked were for SFY 21-22, but the payment did not occur until SFY 22-23. Can I include these costs in my CRCS?



<u>Question 3</u>: I have contractor invoices for hours worked in SFY 21-22, but the payment did not occur until SFY 22-23. Can I include these costs in my CRCS?

- » Expenditures related to the provision of direct health services must be associated with services rendered between July 1, 2021 and June 30, 2022
- » Contractor expenditures may be included in the CRCS, even if payment was not made to contractors until the following SFY
- » Worksheet D includes costs for contracted practitioners who delivered any LEA BOP covered school-based health care services during the SFY
 - Contractors who do not perform covered services must be excluded
 - Administrative contractors (e.g., legal, machine repair, etc.) must be excluded
 - Contracts that cover LEA BOP qualified practitioners <u>and</u> other practitioners must isolate costs for the LEA BOP qualified practitioners
