- I. Summary and Follow-up from the September Meeting.

- a. Enrollment Data (Figures 1& 2)
 - i. Department will update to include Q2 2015 (June) data to next iteration.

- b. Immunizations for Adolescents (Figure 6)
 - i. Dr. Lerner stated that there is minimal value in providing information on combination 1, by Model Type (County Organized Health System, Geographic Managed Care, Two-Plan)
 - ii. Suggested adding HPV vaccination rate.
 - 1. Will take this question to larger MCHAP Panel.
- c. Dental Care (Figure 7)
 - Subcommittee recommended removing all of the verbiage on numerator and denominator for each measure and placing a link to complete definition within a supplemental document or website.
 - ii. Department will update the data to include 2014 data
 - iii. The panel suggested having benchmarks and expected performance ranges as is shown for HEDIS. It was recommended that DHCS look into the Healthy People 2020 for measures on dental sealants and their associated performance targets.
- d. Mental Health Utilization Rates for Children and Youth (Figure 8)
 - Panel would like to see information not just on Specialty Mental Health Services, but include data related to utilization of mild to moderate services that are now covered in managed care and feefor-service.
 - ii. Panel would recommend keeping the Specialty Mental Health Services (SMHS) charts that describe members as opposed to those that describe the quantity of services (such as number of minutes used). Panel also recommended that Substance Use Disorder Services data be included within the dashboard.

 - i. The panel requested standards/benchmarks for the data being provided.

 - i. Should HPV vaccination data be in the pediatric dashboard?
 - ii. Convey the recommendation from stakeholders to have a deep dive discussion on key HEDIS measures.
