

      - 1. Concern about the page in the Medi-Cal application that addressessessets. Can this be modified to make it less concerning to applicants?
      - 2. Request to review an example of all of the forms that an applicant would need to fill out to apply for Medi-Cal
      - 3. Does stakeholder review of the application include parents?
        - a. Ms. Mollow indicated that the public and stakeholders reviewed the application for content, readability and accessibility, and that stakeholder feedback was incorporated into the design and questions on the application.
      - 4. Is 1931(b) Medi-Cal going away?
        - a. Ms. Mollow indicated that Modified Adjusted Gross Income (MAGI) eligibility rules will be applied to most applicants, but that some applicants will still be eligible under 1931(b) rules.

    - i. The information at this meeting was helpful, but there is still a lot of work to be done
      - 1. Are the Panel Members continuing?
      - 2. What is the status of the transition plan for the Panel from MRMIB to DHCS?
      - 3. Mr.Douglas stated that DHCS is beginning a review of stakeholder meetings and the overall stakeholder engagement strategy for the department. He indicated that the department will have a discussion process with stakeholders to determine how to most effectively use stakeholder groups, get information, and have a dialogue.
    - ii. Request to look at the medical and mental health outcomes for consumers with diabetes to make sure that adolescents are counseled
      - 1. How can we make mental health truly work for our families?
      - 2. Would like the Department to give the Panel homework, and use the two hour meetings to discuss the details.

- 1. The members and the subscribers are accountable and have a role in the outcomes
- iv. Not clear what the desired role of the panel is
  - 1. The Department is perceived as isolated, and it does not seem to be the intent.
- v. The Dental Plan is extensive
  - 1. Concern about lack of infrastructure, suggestion to redirect resouces to build an infrastructure.
  - 2. State needs to incentivize WIC programs to work with local services to help people find coverage
  - 3. Want to participate in creative solutions not just react to what happens
- b. Public Comment
  - i. This meeting had a different tone than the MRMIB meetings
    - 1. Want to have a more interactive nature
      - a. DHCS has an extraordinary opportunity to receive feedback
      - there are multiple groups that DHCS receives input from, and it is a good time for the Department to look at this and restructure it
  - ii. Drawing conclusions from the number of complaints may not fully reflect the outcome, as some individuals may not know who to complain to.
