



## Medi-Cal Children’s Health Advisory Panel (MCHAP) Potential Health Care Topics and Ideas January 5<sup>th</sup> 2015

In preparation for the January 2015 MCHAP meeting, DHCS solicited input and recommendations from Advisory Panel members and the public for areas of focus for the MCHAP on health care topics for children in Medi-Cal. Ultimately, the established objectives will also be used in the development of a legislatively mandated report done in 2018 describing the Panel’s accomplishments, effectiveness and efficiency.

DHCS received recommendations from several individuals and organizations, including Advisory Panel members, the California Medical Association (CMA), Children Now, and a letter undersigned by several childrens’ advocacy organizations\*. A listing of the topics received is provided below; the two letters submitted by the childrens’ advocacy organizations provide additional topic-specific information.
