Purpose and History of Children's Dashboard

- Joint DHCS-MCHAP subcommittee, with stakeholders, established in 2015 to develop priorities for children's dashboard
- Intent was to highlight key data across services and delivery systems for children in Medi-Cal
- First dashboard published September 2016



Current Dashboard Elements

- Enrollment data for Managed Care and Fee-for-Service (updated quarterly)
- Language and ethnicity data (updated quarterly)
- Managed Care Health Plans Measures:
Child specific measures (updated yearly)
 - Immunization Rates
 - Access to Primary Care Practitioners
 - Weight Assessments and Nutritional Counseling
 - Rate of Well-Child Visits for 3rd, 4th, 5th and 6th Years of Life



Current Dashboard Elements Continued

- Dental Measures: Managed Care and Fee-For-Service (updated quarterly)
 - Annual Dental Visits
 - Use of Preventative Services
 - Use of Sealants
- Specialty Mental Health Services (SMHS): Statewide and regional data on the number of children and youth under 21 receiving SMHS through county mental health programs (updated annually)



Key Issues Raised by Stakeholders

- Regular release
- Disaggregated race/ethnicity and age data
- Pediatric network adequacy and corrective action
- Mental and behavioral health services
- Consumer experience data
- Child Core Set indicators
- Reconvene subcommittee



Role of the Medi-Cal Children's Dashboard

- High-level view of a selection of measures that cross the Medi-Cal experience for children
- Not inclusive of all data made publicly available about children
- DHCS continues to publish additional data to the DHCS website and the CHHS Open Data Portal

 - Adult and child conducted every three years
 - CHIP performed annually

 - Consumer Experience - Consumer Perception Survey from Youth, their Families, and Adults/Older Adults
 - In 2019 source of referrals to the Mental Health Plan (MHP) and referrals from the MHP to other providers will be collected



CMS Child Core Set Measures Annually

- Child Core Set includes 26 measures
 - Primary Care Access and Preventive Care
 - Maternal and Perinatal Health
 - Care of Acute and Chronic Conditions
 - Behavioral Health Care
 - Dental and Oral Health Services
 - Experience of Care
- Not all measures are currently reported by DHCS
