SUBJECT: APL 20-004: 2021 Deliverables Schedule

The purpose of this Dental All Plan Letter (APL) is to notify all Medi-Cal Dental Managed Care (DMC) plans of the 2021 deliverables schedule for both the Geographic Managed Care (GMC) and Pre-Paid Health Plan (PHP) contracts.

Please note this schedule includes the following changes or additional deliverables, in accordance with recent federal Medicaid managed care regulations:

- Call Center Report: As of Quarter 3 of 2020, the biannual report is due on a <u>quarterly</u> basis, which will be due 30 calendar days after the end of the calendar year (CY) quarter. The new reports are due pursuant to the following schedule: Quarter 1 is due on April 30th, 2021; Quarter 2 is due on July 31st, 2021; Quarter 3 is due on October 31st, 2021; and Quarter 4 is due on January 31st, 2022.
- Linguistic Services Report: As of Quarter 3 of 2020, the biannual report is due on a <u>quarterly</u> basis, which will be due 30 calendar days after the end of the CY quarter. The new reports are due pursuant to the following schedule: Quarter 1 is due on April 30th, 2021; Quarter 2 is due on July 31st, 2021; Quarter 3 is due on October 31st, 2021; and Quarter 4 is due on January 31st, 2022.
- COVID-19 Office Closure Report: Due to the recent COVID-19 pandemic, DHCS has created this <u>new</u> deliverable that is due 15 calendar days after the end of the month. The new/continuing reports are due pursuant to the following schedule: February 15th, 2021; March 15th, 2021; April 15th, 2021; May 15th, 2021; June 15th, 2021; July 15th, 2021; August 15th, 2021; September 15th, 2021; October 15th, 2021; November 15th, 2021; December 15th, 2021; and January 15th, 2022.

This report will include the prior months' data. For example, on February 15th, 2021, the plan will report COVID-19 closures for the period of January 1st through January 31st and will include all unique offices (including, but not limited to, specialist and general practice providers).

- 274 File & Provider Data Submission Reconciliation Form (PDSRF):
 Pursuant to APL 19-004 the plans are to continue to submit the 274 File &
 PDSRF files in addition to the Provider Network Report. The 274 File & PDSRF
 will continue to be due between the 1st and 10th day of the following month. This
 will continue for the foreseeable future to ensure Department-wide provider data
 quality improvement.
- [TAR] Treatment Authorization Request Template & Report: Pursuant to direction from DHCS to the plans on August 24th, 2020, the monthly TAR template was revised to include the top 10 utilized CDT codes and denial reasons for the reported month. The TAR Reports will continue to include this information on all TAR reports moving forward. A request for the updated TAR template shall be sent to dmcdeliverables@dhcs.ca.gov.
