Department of Health Care Services Medi-Cal Dental Performance Measures Report Calendar Year 2014, Fee-For-Service

Background

Welfare and Institutions Code Section 14132.915 requires the Department of Health Care Services (DHCS) to post data for dental fee-for-service performance measures commencing October 1, 2014, for the 2013 calendar year (CY) and annually on or before October 1 for each preceding calendar year thereafter. The following report represents fee-for-service performance for the 2014 CY. It is important to note the following when reviewing the data presented in this report:

- To align with the federal Centers for Medicaid and Medicare Services (CMS) reporting requirements, for the 2014 performance measure reporting period DHCS has transitioned from the Healthcare Effectiveness Data and Information Set (HEDIS)-like to 90 days continuous eligibility in the same plan. HEDIS-like means 11 of 12 months eligibility in the fee-for-service delivery system with no more than a one month gap. This alignment will assist DHCS and the public in assessing Medi-Cal Dental utilization against utilization in other states, as represented through the CMS-416 report. This change in methodology takes effect with the 2014 performance measure report and accounts for the significant difference in utilization between calendar year 2013 and calendar year 2014 reports. As the 90 days continuous eligibility parameter results in a significantly larger number of eligibles in the denominator without a corresponding increase in users, utilization figures for 2014 appear lower than when reported using HEDIS-like criteria for 2013. For example, in the 2013 performance measure report we saw a utilization rate of 32.3% (193,192 users/604,000 eligibles) for the Annual Dental Visit performance measure among 0-3 year olds using HEDIS-like reporting. In the 2014 report, utilization for this measure and age group is 23.4% (235,935 users/1,010,019 eligibles) based on 90 days continuous eligibility reporting. While the numerator/number of users does not vary significantly between years, the denominator/number of eligibles is much greater when using the 90 day continuous eligibility reporting methodology.
- Effective May 1, 2014, certain adult dental benefits were restored in accordance with Assembly Bill 82 (Statutes of 2013). As such, 2014 adult utilization figures reflect a partial year of availability for most dental services.
- The Overall Utilization of Dental Services, Continuity of Care, and Usual Source of Care performance measures draw from data spanning multiple CYs.
 - Continuity of Care and Usual Source of Care measures draw from CYs 2013 and 2014 and were not represented in the 2013 Performance Measures Report.
 - Overall Utilization of Dental Services is presented independently for 2014 CY and as a roll up of 2013 and 2014 CYs.
