#### Welcome and Introductions:

Roll call and introductions were completed. Vera Calloway, Chairperson opened the meeting, Monica Caffey facilitated the remainder of the meeting as the new Chairperson.

### Nomination on Chair-Elect / Changing of Officers:

Vera Calloway, Chairperson facilitated the transition for Monica Caffey, Chair-Elect, to transition to Chairperson. Lorraine Flores was nominated for Chair-Elect.

#### **Approve October 2021 Meeting Minutes:**

A motion to approve the October 2021 minutes with no amendments or edits was made by Barbra Mitchell, seconded by Deborah Starkey. The motion passed with no abstentions.

### **CBHPC ARF Advocacy Efforts Update:**

Vera Calloway provided an update on the committee's efforts on Adult Residential Facility (ARF) advocacy including the committee's hosting of the July 2021 listening session for owner and operators to allow the opportunity to inform community and state what the issues are in maintaining the facilities. Vera also mentioned how Los Angeles County has created an association for ARF operators and that she hopes to see it extend throughout state. Vera reported that the committee met with the governor's office to inform of the dire issues, and with Community Care Licensing (CCL) of Department of Social Services (DSS) on regulatory matters. Vera shared how the efforts of the committee helped raise the visibility of the committee and Council. Monica Caffey also added that the collective efforts has encouraged counties to create a coalition of community providers to support one another while advocating on a larger level.

Barbara Mitchell emphasized the importance to update the budget and the need for the committee to put together more realistic numbers.

#### **Public Comment:**

Uday Kapoor, Board member for National Alliance for Mental Illness (NAMI) for Santa Clara County shared their county faces the same issues of low reimbursement leading to many facility closures. He thanked the committee for their work and encouraged to continue to work with the governor. Uday reported at their recent meeting he invited Los Angeles County to present their use of the bed tracking tool and asked to be available for other counties.

Deanna Pineda, board and care operator since the 1980s, shared that she had to recently close her facility due to financial struggles.

Lorraine Zeller, consumer who once lived in board and care, shared the difficulties she faced as an occupant of the facilities and advocated that consumer voice is an important part in working towards solutions for adult residential care facilities.

### Behavioral Health Continuum Infrastructure Program and Community Care Expansion Update:

Marlies Perez Chief, Community Services Division, Department of Health Care Services (DHCS) presented to the committee on California's significant investment in infrastructure for housing for persons with serious mental illness by providing grants to qualified entities to construct, acquire, and rehabilitate real estate assets. The investment includes \$3 billion in infrastructure funding opportunities is available through DHCS's Behavioral Health Continuum Infrastructure Program (BHCIP) and the Department of Social Services' (DSS's) Community Care Expansion (CCE) program. These investments support the state's priorities to address equity and disparities. BHCIP was authorized through 2021 Welfare and Institutions Code Division 5, Part 7 awarding \$2.1 billion to construct, acquire, and expand properties and invest in mobile crisis infrastructure related to behavioral health through six rounds of funding: Mobile Crisis (\$205M), County and Tribal Planning Grants (\$16M), Launch Ready (\$518.5M), Children and Youth (\$480.5M), Behavioral Health Needs Assessment Phase One (\$480) and Behavioral Health Needs Assessment Phase Two (\$480M).

Julie McQuitty, from the Department of Social Services (DSS) Housing and Homelessness branch, spoke to the committee on the Community Care Expansion (CCE) Program which was established by AB 172 and appropriated \$805 million available over three years. The funding will expand support and services to persons at risk for homelessness or experiencing homelessness who also have behavioral health conditions. Breakdown of funding includes: 75% available for capital expansion projects including acquisition, construction, and rehabilitation of residential care settings and 25% available for rehabilitation to preserve settings that serve the target and prioritized populations, including \$55 million for a capitalized operating subsidy reserve (COSR) for existing licensed facilities including but not limited to those facilities that receive rehabilitation funding. Julie emphasized that increasing the state housing and care continuum will ensure better treatment outcomes and reduce homelessness and

unnecessary institutionalization. She reported that DSS and DHCS are closely collaborating on infrastructure programs and will hold combined stakeholder meetings.

Barbara Mitchell inquired if there are any restrictions of funding for development for locked facilities or involuntary treatment.

Response: No restriction for launch ready phase and is eligible for BHCIP funding. Grants will be provided base on local need in line with state priorities that are cost effective and sustainable.

Hector Ramirez encouraged there to be two or three advisory stakeholder groups to ensure efficacy of feedback.

#### **Public Comment:**

Steve McNally suggested all the infrastructure funding be in one place so counties can be more easily informed of what funding is available.

Barbara Wilson from LA County shared a petition she started for ARFs and encouraged people to sign.

### Discussion of Committee's Next Steps:

Committee members discussed next steps for the committee which included: bringing an updated budget for ARFs to the governor's office, invite Steinberg Institute for insight on funding for homelessness, ensure equal focus on housing as well as homelessness, expand the Olmstead Act to ensure persons are places in least restrictive and supportive living environments, invite consumers from various housing settings to Council meetings to express housing needs and issues.

Julie Snyder, Government Affairs Director will provide an update on the Steinberg Institute's current work to address housing and homelessness in California. She has worked for more than two decades as a legislative advocate and strategist, helping to craft successful legislative, administrative, and ballot initiatives on a wide range of issues including housing, health, climate change, transportation, and homelessness.

Julie also served as a staff member in the California legislature for seven years, including two as consultant to the Assembly Housing and Community Development Committee. She later served as policy director for Housing California for 14 years, working with legislative leaders, department directors, and stakeholders across the political spectrum to secure \$5 billion for housing bonds, pass visionary land use-climate change legislation, and influence more than 100 successful bills reducing homelessness and expanding housing opportunities.
