SUBJECT: SENATE BILL 75 IMPLEMENTATION

The Department of Health Care Services is issuing this Information Notice to inform county Mental Health Plans (MHP) and Drug Medi-Cal trading partners of the implementation of Senate Bill (SB) 75. Pursuant to Senate Bill (SB) 75 (Chapter 18, Statutes of 2015), Section 14007.8 was added to the Welfare and Institutions Code and amended by SB 4 (Chapter 709, Statutes of 2015) to provide full-scope Medi-Cal benefits to two different populations of children:

- ☐ *Transition population* individuals under the age of 19 who are currently enrolled into restricted scope Medi-Cal with unsatisfactory immigration status; and
- New enrollee population individuals under the age of 19 who are eligible for Medi-Cal and have unsatisfactory immigration status not yet enrolled.

Individuals meeting the above criterion were transitioned to full-scope benefits in the eligibility systems beginning May 1, 2016; however, as a result of the requirement validation process, SB 75 full-scope benefits was not implemented in Short-Doyle/Medi-Cal system until June 14, 2016 with an anticipated deployment of SB 75 in the USL Financial System until approximately July 31, 2016. As a result, county MHPs and trading partners are advised to submit respective claims beginning August 1, 2016.

Impact on Electronic Remittance Advices

As previously discussed for preparation for the multiple aid code system enhancement, MHPs may receive separate electronic remittance advice (835) for multiple service lines in one claim with different approved aid codes. As a result of SB 75, MHP Trading Partners may receive separate 835 with multiple approved claims with the same claim submitter identification. This claim split is needed to reflect accurate representation of claim payments.
