CALIFORNIA CODE OF REGULATIONS, TITLE 9, SECTION 3510

This Information Notice informs Counties of the Annual (MHSA) Revenue and Expenditure Report (RER) requirements for Fiscal Year (FY) 2013-14. A copy of the MHSA County Fiscal Accountability Certification Form, RER instructions, and worksheets are enclosed (Enclosures 1, 2, and 3).

The reporting for the RER should reflect all activity that occurred between July 1, 2013 and June 30, 2014.

For FY 2013-14, funds reported as revenue received from the Mental Health Services Fund must equal the allocation amounts provided by the State Controller's Office (SCO) for FY 2013-14. The amounts are available at:

http://www.sco.ca.gov/ard\_payments\_mentalhealthservicefund.html.

Expenditures should be recognized in the period that the fund liability is incurred. (Accounting Standards and Procedures for Counties, SCO, May 2013)

Counties should continue to comply with all requirements in the California SCO publication, Accounting Standards and Procedures for Counties, and with the requirements set forth in the MHSA and other applicable laws, including the prohibition against supplantation.

## Submission:

The RER must be submitted electronically to <a href="MHSA@dhcs.ca.gov">MHSA@dhcs.ca.gov</a> and <a href="MHSOAC@mhsoac.ca.gov">MHSOAC@mhsoac.ca.gov</a> using the Excel template (do not submit a PDF document). In the subject line, include "(county name) FY (year) MHSA Rev and Exp Report." DHCS requests counties submit their Fiscal Year 2013-14 RER by October 30, 2015.

Accordingly, Counties will need to maintain all accounting and management information system reports used to substantiate what was reported in the RER for a minimum of seven years from the end of the fiscal year in which the records were prepared for future audit purposes.
