PURPOSE

This bulletin communicates revisions to the Department of Alcohol and Drug Programs' (ADP) Drug Medi-Cal (DMC) Program Aid Codes Master Chart. The revised Aid Codes Master Chart can be accessed using the following link on ADP's website: http://www.adp.ca.gov/Library/index.shtml.

The chart identifies the Aid Codes that are authorized for use in the DMC Program administered by ADP. Certified DMC programs can receive reimbursement for providing medically necessary substance use treatment services to Medi-Cal eligible beneficiaries whose Aid Codes are identified on ADP's Aid Codes Master Chart.

DISCUSSION

ADP has made the following revisions to the Aid Codes Master Chart:

• Added Aid Code 4T – This code provides full-scope Medi-Cal benefits for children in the Social Security Act, Title IV-E Kin-Gap program. Beginning in January 2011, counties will start placing into Aid Code 4T the new and existing cases determined to be eligible for the federally-funded Kin-GAP program. If new Kin-GAP cases are not federally eligible they will be placed into Aid Code 4G. Existing Kin-GAP cases, coded to either Aid Codes 4F or 4G, will remain in 4F and 4G until moved into the appropriate Aid Code upon assessment for eligibility in the new State or federally-funded Kin-GAP Program. The Department of Health Care Services (DHCS) activated this code for ADP effective January 13, 2011.

Added Aid Code 74 – Under the Omnibus Budget Reconciliation Act,
 Percent program, this code provides emergency services for children having undocumented/nonimmigrant alien status, but who are otherwise eligible. It provides emergency services to eligible children aged 1 to 6 years, and beyond 6 years when inpatient status, which began before their 6th birthday, continues, and family income is at or below 133 percent of the federal poverty level. The DHCS activated this code for ADP effective February 25, 2011.
