

**County Share of SAPT Block Grant Women Services Expenditure Requirement**

**Exhibit G**

Based on FY 2011-12 allocation dollars on which disbursement percentages were calculated for the following Local Revenue Fund 2011, Health and Human Services Account, Subaccounts:

- Women and Children's Residential Treatment Services Subaccount
- Nondrug Medi-Cal Substance Abuse Treatment Services Subaccount (Perinatal Part only)
- Drug Medi-Cal Subaccount (Perinatal Part only)

In FY 2012-13, the single Behavioral Health Subaccount replaced the separate Health and Human Services Subaccounts.

Methodology: The expected FFY 2014 SAPT Perinatal Set-Aside allocations in column G were subtracted from the \$26,349,134 total Women Services spending requirement to determine the \$9,295,134 residual county share. The column G allocations were revised for FY 2013-14 due to Imperial County opting to no longer receive a SAPT Perinatal allocation. In column H, the residual county share was then applied to counties in proportion to each county's share of the total FY 2011-12 perinatal realigned funds on which the State Controller's Office disbursement percentages were based. These funds were historically counted toward meeting the Women Services spending requirement, when the funds were General Funds.
