This notice communicates the Department of Health Care Services (DHCS) Website location of the **SDMCII Aid Code Master Chart**. The most recent version of chart can be accessed using the following link to the DHCS website to view the MedCCC Library page.

The Aid Code Master Chart (MC) is shared by Drug Medi-Cal (DMC) and Mental Health Services (MHS). The information herein is for DMC.

The opening pages of the MC include helpful notes and explanations regarding the organization of the MC and the information therein. There is also historical information and a Change Log detailing revisions, added/removed codes and comments.

The MC arranges the aid codes in sections depending on the applicable Social Security Act Title and the Federal Financial Participation percentage.

The columns in the MC:

- List the code;
- Indicate if the Medi-Cal benefit is Full Scope or Restricted;
- Describe the program to which the aid code applies and the population that is covered under the code;
- Indicate whether the aid code is authorized for DMC use, as noted by **Yes** in the DMC column;
- Note the date the aid code became effective in the Short Doyle Medi-Cal II (SDMCII) adjudication system;

- Note the date an aid code was made inactive in the Medi-Cal Eligibility Determination System; and
- Identify whether the population covered by the aid code could include Early and Periodic Screening, Diagnosis, and Treatment eligible youth.
