Final Filing Date: The testing office will accept applications continuously. However, pre-established filing dates are scheduled every three months. The filing dates are:

Who Should Apply: Applicants who meet the minimum qualifications as stated on this bulletin may apply for and take this examination.

Once you have taken this examination, you may not retake it for **12** months.

How to Apply: How to Apply: Candidates are required to submit the following two items by the established filing date:

1. Examination/Employment Application (STD 678)

2. Training and Experience Evaluation

The STD 678 must be completed and submitted via one of the methods indicated below. Additionally, the Training and Evaluation must be completed and submitted separately through SurveyMonkey using the link under, "Taking the Examination" below.

To learn more about the job and testing arrangements, contact the testing office shown below. Completed applications must be received or postmarked by one of the cut-off dates. Applications postmarked or personally delivered after the cut-off date will be held and processed in the next examination administration. Dates printed on envelopes by mobile barcodes or equivalent mobile print technology are not acceptable proof of the date the application and any other required documents or materials were filed. MINIMUM QUALIFICATIONS

It is your responsibility to make sure you meet the education and/or experience requirements stated on this bulletin by the date you submit your application. Your signature on your application indicates that you have <u>read</u>, <u>understood</u>, and <u>possess</u> the basic qualifications required. Part-time or full-time jobs, regardless of whether paid or volunteer positions, and inside or outside California state service will count toward experience.

NOTE: Applications/resumes MUST include "to" and "from" dates (month/day/year), time base, civil service class title(s), and range (if applicable). Applications/resumes received without this information will be rejected.

Qualifying experience may be combined on a proportionate basis if the following requirements include more than one pattern and are distinguished as either I, II, or III, etc.

Possession of the legal requirements for the practice of medicine in California as determined by the California Board of Medical Quality Assurance or the California Board of Osteopathic Examiners. (Applicants who are in the process of securing approval of their qualifications by the Board of Medical Quality Assurance or the Board of Osteopathic Examiners will be admitted to the examination, but the Board to which application is made must determine that all legal requirements have been met before candidates will be eligible for appointment.)

AND

Either I

One year of experience in California state service performing the duties of a Medical Consultant I, Department of Health Care Services.

Or II

Three years of experience in the practice of medicine (exclusive of internship), including one year of administrative, supervisory, or consultant experience in a public health or welfare agency, or in a medical care or rehabilitative program.

NOTE: Applicants using education to meet the minimum requirements must provide a copy of their degree or transcripts.

POSITION DESCRIPTION

The Medical Consultant II, Department of Health Care Services, works either: (1) in a region or large district office to give professional advice and guidance on the medical aspects of the Department's programs and to direct and coordinate the work of a group of medical consultants and technical staff; or (2) in a staff capacity, to review the work of field offices to assure the quality and uniformity of decisions; and to provide technical guidance to consultants in the field, and to providers, beneficiaries, medical societies, and community organizations; or participate in the implementation and interpretation of state and federal laws, as well as the formulation of state laws, regulations, policies, and procedures relating to the medical aspects of departmental programs; or (3) in a staff

capacity, to give professional advice and guidance on assuring that quality medical care is delivered to Medi-Cal beneficiaries enrolled in contracting managed care plans, and to provide technical guidance to health plan medical directors and state contract management staff; and to do other work as required.

Positions exist with the Department of Health Care Services statewide.

EXAMINATION INFORMATION

This examination consists of the following component(s):

Training and Experience Evaluation – Weighted 100% of the final score.

No written test is required, and no interview will be conducted.

The examination is designed to elicit specific information regarding each candidate's training and experience relative to the testing classification. Responses to the examination will be assessed based on pre-determined rating criteria. In appraising the relative qualifications of candidates, consideration will be given to the extent and type of pertinent training and experience over and above that which is required under, "Minimum Qualifications".

The Department of Health Care Services reserves the right to revise the examination plan to better meet the needs of the service if circumstances under which this examination plan changed. Such a revision will be in accordance with civil service laws and rules, and all competitors will be notified.

TAKING THE EXAMINATION

EXAMINATION SCOPE

Ratings will be determined based on the depth and breadth of professional education and experience beyond what is minimally required. Emphasis will be placed on measuring, relative to job demands, each competitor's:

Knowledge of:

- 1. Principles and practices of general medicine and surgery with particular reference to the techniques and trends in the diagnosis of physical and mental handicaps and in treatment programs for such handicaps
- 2. Interrelationships of federal, state, and local professional and voluntary public health and welfare agencies, and the programs and services of such agencies
- 3. Principles of preventive medicine
- 4. Principles of community organization
- 5. Principles and practices of personnel management
- 6. Department's Equal Employment Opportunity Program objectives
- 7. A manager's role in the Equal Employment Opportunity Program and the processes available to meet equal employment opportunity objectives

Ability to:

- 1. Direct the work of a group of medical consultants
- 2. Interpret and apply the medical policies standards, rules, and regulations of the Department's program
- 3. Evaluate the quality and scope of medical services provided by the Medi-Cal Program
- 4. Analyze situations accurately and take effective action
- 5. Establish and maintain cooperative relations with those contacted in the work
- 6. Write effectively
- 7. Speak effectively before professional and lay groups
- 8. Effectively contribute to the Department's equal employment opportunity objectives

GENERAL QUALIFICATIONS

Applicants must possess essential personal qualifications including integrity, initiative, dependability, good judgement, the ability to work cooperatively with others, and a state of health consistent with the ability to perform the assigned duties of the class. A medical examination may be required.

ELIGIBLE LIST INFORMATION

Possession of the entrance requirements does not assure a place on the eligible list. In order to obtain a position on the eligible list, a minimum rating of 70% must be attained. Names of successful competitors are merged into the list in order of final scores regardless of the date. Eligibility expires **12** months after it is established unless the needs of the service and conditions of the list warrant a change in this period.

Eligible lists established by competitive examination, regardless of date, must be used in the following order: 1) sub-divisional promotional, 2) departmental promotional, 3) multi-departmental promotional, 4) service-wide promotional, 5) departmental open, 6) open. When there are two lists of the same kind, the older must be used first.

Veterans' Preference will be granted for this examination. In accordance with Government Codes 18973.1 and 18973.5, whenever any veteran, or widow or widower of a veteran achieves a passing score on an open examination, he or she shall be ranked in the top rank of the resulting eligible list.

Veteran status is verified by the California Department of Human Resources (CalHR). Information on this program and the Veterans' Preference Application (STD. Form 1093) is available online. Additional information on veteran benefits is available at the Department of Veterans Affairs.
