TO: All County California Children's Services Administrators

SUBJECT: California Children's Services Fiscal Year 2021-22 California Children's Diagnostic, Treatment, and Vended Therapy; Optional Targeted Low-Income Children's Program; California Children's Services Dental; and Medical Therapy Program Therapy Funding Certifications

The purpose of this Information Notice (I.N.) is to request counties to submit their fiscal year (FY) 2021-22 certification of county funds for California Children's Services (CCS) diagnostic, treatment, and vended therapy; optional targeted low-income children's program; dental; and Medical Therapy Program (MTP).

In accordance with Health and Safety Code Section 123940, each county is required to appropriate a sum of money for its share of diagnosis, treatment, and therapy services for children enrolled in the CCS program. In order to ensure that counties have allocated these funds, the Department of Health Care Services requests counties to complete the enclosed CCS Certification of County Appropriation form and email a digitally signed copy of the document to DHCSSCAdmin@dhcs.ca.gov by August 20, 2021.
