***Due to the design or model of service provision in the setting, individuals have limited, if any, opportunities for interaction in and with the broader community, including individuals not receiving Medicaid-funded HCBS***

<p><b>Summary of Evidence</b></p>	<p>Adat Shalom I is <b>one of six homes</b> operated in the same general area by this provider. The same activity calendar was used in each home. Individuals had limited opportunities to participate in activities in the community because Adat Shalom I did not plan community activities as part of its plan for service. There were blanket restrictions in place including doors were alarmed and locked and individuals were unable to enter their home without staff intervention. In addition, staff wore scrubs which contributed to the home appearing institutional.</p>
<p><b>Summary of Remediation Strategy</b></p>	<p>Adat Shalom I addressed the blanket restrictions and the lack of individualization in activities in the various locations.</p> <p>In response to the lack of individualization in activities and limited opportunities to participate in activities in the community, Adat Shalom I developed with everyone a list of their preferences, hobbies, favorite activities, favorite restaurants, and things the person would like to try. During regular meetings with individuals, staff encourage individuals to make suggestions and talk about what they would like to do in the next month. The staff person then creates an activity. Staff meet with individuals to talk with them about the opportunities to do things with other people living with them.</p> <p>Adat Shalom I ensures that individuals have the option to have a key to their home unless there is an assessed need that is documented in the person-centered plan with goals to lessen restrictions. Alarms are still in use to promote safety and not to restrict or monitor individual’s movement. The alarms are discussed at admission and regularly after that. Adat Shalom I plans to review restrictions in place and to set goals, when able, to lessen the restrictions.</p> <p>Although staff wearing scrubs contributes to Adat Shalom I appearing to be institutional, it does not directly impact the individual’s access to the community.</p>

<b>Summary of Evidence</b>	Adat Shalom I did not schedule community activities other than taking walks in the neighborhood or for picnics in the park. Adat Shalom I had the same activity calendar as the other five homes operated by this same provider.
<b>Summary of Remediation Strategy</b>	In response to the lack of individualization in activities and limited opportunities to participate in activities in the community, Adat Shalom I developed with everyone a list of their preferences, hobbies, favorite activities, favorite restaurants, and things the person would like to try. During regular meetings with individuals, staff encourage individuals to make suggestions and talk about what they would like to do in the next month. The staff person then creates an activity. Staff meet with individuals to talk with them about the opportunities to do things with other people.
