#### SETTING SUMMARY: COMPLIANCE OVERVIEW AND REMEDIATION STRATEGY

#### Setting is located in a building that is also a publicly or privately-operated facility that provides inpatient institutional treatment

Summary of Evidence	Ararat Home of Los Angeles  . There were practices that contributed to the institutional nature of Ararat Home of Los Angeles. They had security cameras in shared areas, individuals were not permitted to have overnight guests, there was a secure area for medication carts, and individuals were not able to open the door to their home when returning after 8:00 pm.
Summary of Remediation Strategy	Ararat Home of Los Angeles offered at the time of the assessment, opportunities for individuals to be engaged in the broader community. Individuals are supported to participate in community activities with and without their housemates or roommates. Ararat developed policies and procedures to describe the use of security cameras and encourage visitors.  Individuals and families are informed upon admission of 24-hour video surveillance for safety in the hallways. It is included in the Admissions Agreement, and signs are posted in the main entrances and on each floor. The provider explained that the use of video recording allows them to respond immediately to any fall and to review in the event of any incident. The administrator, Director of Nursing, and Chief Operating Officer are authorized to listen/view the recording. Recordings are erased after seven days. The Visitor Policy says individuals may have overnight guests. Visitors do not have to sign in and out. Individuals can now use the access cards that previously opened their bedroom doors to open the front door so they can enter their home when returning after 8:00 pm.  Although, Ararat Home of Los Angeles is on the same property and governed by the same entity, they promote community integration. The medication cart storage area and security cameras do not impact individuals' ability to access the community. Ararat has submitted a plan to address individuals having visitor when they want and having access to their home.
