## **REASON(S) FOR HEIGHTENED SCRUTINY (HS)**

#### SETTING SUMMARY: COMPLIANCE OVERVIEW AND REMEDIATION STRATEGY

Summary of	Villa Siena is part of a retirement community that provides three levels of care, including assisted living and
Evidence	skilled nursing. The retirement community includes the main assisted living quarters, skilled nursing quarters, and living quarters for nuns who volunteer at the assisted living and skilled nursing quarters. Individuals living in the Assisted Living quarters of Villa Siena experienced restrictive practices. Individuals with a diagnosis of dementia were not permitted to go out without supervision. Individuals did not all have keys to the front door of their home. Individuals were not able to use the commercial kitchen or laundry. Individuals were not supported to have visitors when they chose. Villa Siena used video monitoring in shared areas in the assisted living quarters.



Summary of Remediation Strategy	In response to the restrictive practices that impacted an individual's access to the broader community, Villa Siena will ensure that individuals are not subject to restrictions without an assessed need that is documented in their Individual Service Plan (ISP) and reviewed with their person-centered team. Villa Siena will ensure that individuals are free to come and go from their home into the community as they choose unless the person-centered team has identified a need based on assessments that warrants a limitation or restriction. Individuals will have a key to the front door of their home unless there is an assessed need documented in their ISP. Any restrictions will be reviewed as conditions change but no less than annually.
	Although individuals are unable to go into the commercial kitchen, individuals have a microwave and kitchen in their bedroom unless otherwise documented in their ISP. Individuals have access to snacks they prefer in shared areas in the quarters. Individuals keep food and drinks in their rooms. Staff can assist if individuals want or need assistance with a getting or making a snack. Villa Siena is exploring options for individuals who want to do their laundry to have access to a washer and dryer. Until laundry appliances can be installed within the assisted living quarters or retirement community, the administrator and staff will work with individuals who want to do their laundry to support the individuals in doing their laundry. Access to laundry and support to do laundry will be available to all individuals unless the person-centered team assesses a need that results in additional supports, limitations, or restrictions.
	Individuals will be supported to have visitors as they want, including overnight. The administrator will update the visitor policy and hours rules to eliminate set visiting hours and restrictions about overnight visitors.
	The administrator will create a video monitoring and disclosure policy. The policy will provide information about where cameras are place, who has access to the recordings, how recording are stored, and when they are disposed of. to include the placement of cameras, access to recordings, storage of recordings, and disposal of recordings. Signs will be displayed so everyone is aware of the use of video cameras.



Although Villa Siena is on the same property as a skilled nursing facility (SNF), they have addressed restrictive practices to ensure that individuals will experience restrictions only based on their assessed needs as documented in their ISP. The person-centered team will review any restrictions as needed, and at least annually. Individuals have opportunities for community integration.
