# **REASON(S) FOR HEIGHTENED SCRUTINY (HS)**

- Setting has the effect of isolating individuals receiving Medicaid Home and Community Base Services (HCBS) from the broader community of individuals not receiving Medicaid HCBS

## SETTING SUMMARY: COMPLIANCE OVERVIEW AND REMEDIATION STRATEGY

#### Setting is located in a building that is also a publicly or privately-operated facility that provides inpatient institutional treatment

Summary of Evidence	Vista Cove at San Gabriel / Royal Vista San Gabriel is in the same building that provides skilled nursing. Vista Cove at San Gabriel/Royal Vista San Gabriel owns and operates the skilled nursing facility (SNF). There is a separate license and separate staff. The SNF was separated from the assisted living services with a key coded door.
	Individuals receiving memory care services did not have the opportunity for interaction in and with the broader community with or without their housemates/roommates. There were systemic practices that impeded community access. Vista Cove at San Gabriel/Royal Vista San Gabriel used video monitoring. The doors were locked at night and Individuals were let into their home by the security guard. Doors are alarmed at dark. The gates on the fence were locked. Individuals in memory care experienced locked doors secured with a keycode which they did not have.



Summary of Remediation Strategy	Although Vista Cove at San Gabriel/Royal Vista San Gabriel is in the same building as a SNF, they operate separately. Individuals living at Vista Cove at San Gabriel/Royal Vista San Gabriel have opportunities for interaction in and with the broader community. They intend to support individuals to participate in community activities as they choose unless there is an assessed need documented in their Individual Service Plan (ISP). Staff will be available to support individuals in the community. Staff will help arrange transportation, help with planning activities, and go with the individual or groups to provide necessary support. The administrator will have ongoing conversations with individuals to get input and feedback on community activities. The staff will use the information gathered in these conversations and the ISP that documents wants, needs, goals, likes, and preferences to create an activity calendar. Everyone will be invited to participate in activities as indicated in their ISP regardless of if they are receiving assisted living or memory care services.
	Vista Cove at San Gabriel/Royal Vista San Gabriel addressed the systemic practices that impeded community access. They developed a system to ensure that any restrictions were based on individual's assessed need, documented in the ISP, and reviewed at least annually. Individuals will be able to move about their home and access their community based on their assessed needs as documented in their ISP and reviewed annually. Individuals will have a key or keycode access to interior and exterior doors unless otherwise documented in their ISP. Alarms are used to alert staff if the door has been opened at night. It is not intended to restrict individuals. The admission agreement will be updated to describe the use of the alarms. Individuals will be informed at admission and annually. The administrator will create a video monitoring policy that describes the place of cameras, access to recordings, storage of recordings, and disposal of recordings. Signs will be posted so everyone knows that video cameras are in use.
