# APTC Women who report a change of being pregnant • Stakeholders provided input on the contextual help document. • The English and Spanish versions were posted on Wednesday. They are 'live' on the application when clients click 'learn more'. • DHCS confirmed the readability issue was addressed. • DHCS: The Change Request for women enrolled in Covered California coverage who report a pregnancy is being prioritized on the road map. It is anticipated to be included in release 16.9 • Covered California: We can identify the women who transitioned to M9. It is not possible to prevent the transaction, because it occurs in real time. • Advocates: This change may be more beneficial for some women. We need to ensure what is best for the woman is operationalized and these women are informed of their choices. 1) Consider notifying each of these women by sending a simple letter. 2) Could we see a draft special notice? [Action Item]: Covered California will forward the draft informing letter to DHCS and advocates.

# **Agenda & Notes** Covered California is working with counties and plans to get them back into coverage. **MCAP Updates** DHCS: Closely monitoring the integration of MCAP into CalHEERS and responding promptly to an cases with identified concerns. Since the beginning of November, approximately 2000 applications were recieved. This is fairly consistent with the number of applications during the same time in previous years. DHCS identified a trend where individuals submit applications and make subsequent reported changes; which is impacting the programming logic. Per MCAP Phase 1, the programming logic is based on a default 2. system. 1. For women already enrolled in a QHP, the default is to leave them in their QHP. 2. The default for a new pregnant applicant, who is otherwise eligibile, is MCAP. DHCS: If a woman was already in a QHP and reported a pregnancy, and fell within MCAP income range, she would stay in her QHP; receiving notification she could elect to transition to MCAP.
