SUBJECT: Errata to All County Welfare Directors Letter 20-12

The purpose of this All County Welfare Directors Letter (ACWDL) erratum is to provide an end date for the income limits for the Aged, Blind, and Disabled Federal Poverty Level (ABD FPL) program effective April 1, 2020, due to the implementation of the ABD FPL program expansion, effective December 1, 2020.

Corrections to ACWDL 20-12 are recorded using the following:

Below is the language from ACWDL 20-12, with revisions located on pages 1 and 2.

### **Purpose**

The purpose of this All County Welfare Directors Letter (ACWDL) is to provide updated income limits for the Aged, Blind, and Disabled Federal Poverty Level (ABD FPL) program that are effective April 1, 2020, **through December 1, 2020. After December 1, 2020, counties shall follow the guidance provided in ACWDL 20-24 regarding the income limits for the ABD FPL program.**

Welfare and Institutions Code, [Section 14005.40\(c\)](#) requires that the ABD FPL effective income limit be the greater of:

- The [Supplemental Security Income/State Supplementary Payment \(SSI/SSP\)](#)<sup>1</sup> rates, or
- 100 percent of the applicable FPL plus the standard disregard for an individual (\$230) or a couple (\$310).

The income limit for an ABD FPL individual will be \$1,294. This income limit is equal to \$1,064 (100 percent of the FPL for an individual) plus the \$230 standard disregard for an individual.

The income limit for an ABD FPL couple (except when both are blind) will be \$1,747. This income limit is equal to \$1,437 (100 percent of the FPL for 2 Adults) plus the \$310 standard disregard for couples. This includes cases where one individual in a couple is blind, and the other is aged or disabled.

The income limit for Blind FPL couples will remain the same as the May 1, 2009, SSI/SSP rate for blind couples because it is higher than 100 percent FPL for two, plus the \$310 income disregard for couples.

Use the following income limit for couples where both individuals meet the Blind FPL guidelines:

- Both individuals that make up the couple are blind: \$1,751

Counties shall reevaluate eligibility based on the revised income limits for all cases containing ABD individuals back to April 1, 2020, that did not have eligibility reevaluated through the Statewide Automated Welfare System (SAWS) batch runs.
