SUBJECT: Pickle Tickler Type 52 Notice of Action Address Database

The purpose of this Medi-Cal Eligibility Division Information Letter is to provide counties with the current Pickle Tickler Type 52 Notice of Action (NOA) address database and to request county updates.

Pursuant to the Lynch v. Rank lawsuit, the Pickle Tickler Type 52 NOA is mailed annually to the home address of individuals who currently receive Title II Retirement, Survivors, and Disability Insurance payments, and were determined ineligible for the Pickle Program, immediately following discontinuance from Supplemental Security Income/State Supplementary Payment programs.

In December of each year, the Department of Health Care Services mails Type 52 NOAs, as described above. The county contact information listed on the bottom of the NOA aids potential Pickle Program eligible individuals requesting county assistance to apply for the Pickle Program. In conducting your review and/or updates, please be mindful of the fact this contact information is widely distributed.
