SUBJECT: Pre-Release Medi-Cal Application Mandate Readiness Assessment
Form for County Correctional Facilities/County Youth Correctional
Facilities - Related to ACWDL 22-27
(Reference Assembly Bill 133 and California Penal Code Section
4011.11)

The purpose of this letter is for Department of Health Care Services (DHCS) to introduce and disseminate the Pre-Release Application Mandate Readiness Assessment Form. This form is to be completed by County Correctional Facilities/County Youth Correctional Facilities (e.g., jails, youth detention facilities) to provide DHCS with information about their readiness to implement the mandatory Pre-Release Medi-Cal Application Process, as codified by [Assembly Bill \(AB\) 133](#) (Chapter 143, Statutes of 2021), entitled the “California Advancing and Innovating Medi-Cal (CalAIM) Initiative”. This process will help to ensure that, if determined eligible, all incarcerated adults and youths within County Correctional Facilities and County Youth Correctional Facilities have access to needed Medi-Cal covered services and care upon their re-entry into the community.

Commencing January 1, 2023, the mandatory Pre-Release Medi-Cal Application Process will go live. As part of the preparation, County Welfare Departments (CWDs) and County Correctional Facilities/County Youth Correctional Facilities are required to attest to their readiness for implementing a Pre-Release Medi-Cal Application process by completing and submitting the enclosed Pre-Release Application Mandate Readiness Assessment Form. DHCS will use the attestations to gauge overall readiness and identify counties that may require technical assistance to achieve readiness within the timeframe mandated by statute. (Refer to Penal Code § 4011.11)

BACKGROUND

Effective January 1, 2023, CalAIM requires all counties to implement a Pre-Release Medi-Cal Application Process to ensure all inmates and youth who are released from County Correctional Facilities and County Youth Correctional Facilities receive timely access to Medi-Cal services, if otherwise eligible. DHCS issued All County Welfare Directors Letter 22-27 to establish a pre-release Medi-Cal application policy for both County Correctional Facilities and County Youth Correctional Facilities and/or their designees and updated existing policy for CWDs.

As outlined in Penal Code section 4011.11, the board of supervisors in each county, in consultation with the county sheriff and chief probation officer, respectively, shall designate an entity or entities to assist county jail inmates and youth with submitting an application for, or otherwise assisting their enrollment in, a health insurance affordability program consistent with federal requirements. The designated entity or entities (CWDs, County Correctional Facilities/County Youth Correctional Facilities, Community Based Organizations (CBOs), or other contracted entity) must work together to facilitate the enrollment of inmates and youth in health insurance affordability programs on or before their date of release by developing a process to inform CWDs of the incarceration status of their inmates and youth, in order for CWDs to appropriately suspend and activate (unsuspend) Medi-Cal coverage for beneficiaries.

If CWDs and County Correctional Facilities/County Youth Correctional Facilities have existing pre-release application processes that meet the requirements of the CalAIM Pre-Release Medi-Cal Application process, such processes can be leveraged and built upon, if necessary, to comply with this mandate.

READINESS SELF-ATTESTATION FORM- ACTION REQUIRED

County Correctional Facilities/County Youth Correctional Facilities must complete and submit the enclosed Pre-Release Application Mandate Readiness Assessment Form by December 1, 2022. Completed forms are to be submitted to DHCS at CalAIMJusticePreReleaseApps@dhcs.ca.gov.

The Pre-Release Application Mandate Readiness Assessment Form will be completed by the County Correctional Facilities/County Youth Correctional Facilities to self-attest to their organization currently having processes in place, or will have processes in place, by January 1, 2023, to support pre-release Medi-Cal applications. We encourage County Correctional Facilities/County Youth Correctional Facilities to consider and account for any future improvement in the design and modifications to application and enrollment processes. Additionally, the form will also ask the County

Correctional Facilities/County Youth Correctional Facilities to specify any aspects of the process for which technical assistance from DHCS is requested.

As the January 1, 2023 implementation deadline approaches for the CalAIM Mandated County Inmate Pre-Release Application Process, DHCS is requiring County justice agencies and County Social Service Departments to attest to the readiness of correctional facilities (e.g., jails, youth correctional facilities) to implement a process for pre-release Medi-Cal applications by completing and submitting the following form to DHCS by December 1, 2022. DHCS will use the attestations to gauge overall readiness and identify counties that may require technical assistance to achieve readiness within the timeframe mandated by statute.

Background: Per [California Penal Code § 4011.11](#), and further described in All County Welfare Directors Letter #22-27, all counties are required to implement a CalAIM Mandatory Pre-Release Medi-Cal Application Process for inmates of county jails and youth correctional facilities by January 1, 2023. The goal of this mandate is to ensure that all Medi-Cal eligible individuals have timely access to Medi-Cal services upon release into the community. Furthermore, pre-release Medi-Cal enrollment will allow individuals to access a targeted set of pre-release Medi-Cal services that the Department of Health Care Services (DHCS) has proposed to cover under an [1115 waiver amendment](#), which is currently under negotiation with the Centers for Medicare/Medicaid Services (CMS). To guide implementation of pre-release Medi-Cal applications, DHCS has convened working and office hour sessions with key stakeholders since November 2021 and released an issue brief, entitled [Strategies for Conducting Pre-Release Medi-Cal Enrollment in County Jails](#), which highlights best practices for implementing pre-release Medi-Cal application processes in jails and youth correctional facilities.

PATH Round 2 Funding: Counties may apply for Providing Access and Transforming Health (PATH) Round 2 Funding to support the implementation of processes, protocols, and IT system modifications required to implement their pre-release Medi-Cal application process.
