SUBJECT: Medi-Cal 250 Percent Working Disabled Program (250 Percent WDP)
Premium Payment Methods

The purpose of this letter is to advise counties that the Department of Health Care Services (DHCS) recently mailed the attached informational flyer, Important Information About Medi-Cal 250 Percent Working Disabled Program Premium Payment Methods, (MC 0384) to all 250 Percent WDP participants, alerting them to a change in the Post Office box number for premium payments. The notice also reminds those participants with internet access that they may elect to pay their monthly premium on-line via Electronic Funds Transfer (EFT).

Medi-Cal County eligibility workers are also encouraged to direct beneficiaries to use the EFT system, which can be found at <http://www.paycalifornia.com>. **IMPORTANT INFORMATION ABOUT
MEDI-CAL 250 PERCENT WORKING DISABLED PROGRAM
PREMIUM PAYMENT METHODS**

Electronic Funds Transfer (EFT)

You may now make your 250 Percent Working Disabled Program (WDP) payment on the internet through an electronic funds transfer (EFT). It's easy and it's free! You can securely transfer your payment directly from your checking account to the Department of Health Care Services (DHCS). Before you start, make sure to have your bank or credit union account and routing numbers. You can contact your bank/credit union for your account information.

To make your EFT payment, follow these steps:

****Be sure to have your bank account and routing numbers in front of you before you start.**

1. Go to the payment website at: www.paycalifornia.com .
2. Click on "California Department of Health Care Services."
3. At "DHCS Account Number," enter your Client Index Number (CIN), which is the first eight numbers and one letter of your I.D. number which can be found on your Benefits Identification Card. Click "continue."
4. Continue following the online instructions.
5. Once you schedule an EFT payment, you will be given a reference number to keep for your records.
